
- The tender must be valid for at least 120 days from the date of opening of tenders.
- Tenders received telegraphically, through telex, conditional tender or manually or fax shall not be accepted.
- GGSSTP reserves the right to accept or reject any or all tenders without assigning any reason and no claim on this account shall be accepted.
- Tenders received after the last date and time of opening of tender shall not be accepted. If the due date happens to be holiday, tenders shall be received and opened on the next working day at the same time.
- The tenderers shall specify clearly his rates as per Performa attached at part-III of this NIT.
- Tenders received without Earnest Money shall not be opened.
- The firm should have independent GST Registration No. and will submit a copy of same.
- The tenderers shall be required to submit fixed earnest money as below:
  - If the tender value is more than Rs. 50,000/-: Nil
  - If the tender value is more than Rs. 50,000/- then tenderers will be required to submit EMD @ 2% of tender value round off to the multiple of Rs. 10/- on higher side subject to minimum Rs. 5000/- and maximum of Rs. 10 Lacs.

Public Sector Undertaking fully owned by the Punjab Govt/Central Govt/Other state Govt shall be exempted from depositing EMD provided that a certificate of Govt ownership shall be submitted in the envelope for EMD.

**Terms and Conditions**

1. The eligible firm may procure tenders from office of SE/HQ, GGSSTP Ropar by depositing tender fee of Rs 500/- (**Rupees Five Hundred only**) + 18% GST or as applicable.

2. **Pre-Qualification Requirement: -**

**Pre-qualification requirement for registration and eligibility for this tender:-**  
Tenders of only those technically suitable firm will be considered and opened who are registered with GGSSTP/GHTP/NTPC or other such central & state government organizations for the jobs of "Refurbishment / Reconditioning works of Mechanical spares like shafts/sleeves/Impellers/similar mechanical items" subject to the following criteria:-

- i) Proof of having experience of executing the jobs of "Refurbishment /Reconditioning works of Mechanical spares like shafts/sleeves/Impellers/similar mechanical items" having minimum contract value of either of the following:-
  - a) Single completed work order or supply order to BHEL, NTPC and other state/ private owned thermal power plants/Any other Industry covering the above work costing (including all taxes) not less than Rs. 1.81 Lacs.  
OR
  - b) Two, completed work order or supply order to BHEL, NTPC and other state/ private owned thermal power plants/Any other Industry covering the above work costing (including all taxes) not less than Rs. 1.09 Lacs.  
OR
  - c) Three, completed work order or supply order to BHEL, NTPC and other state/ private owned thermal power plants/Any other Industry covering the above work costing (including all taxes) not less than Rs. 0.90 Lacs.
- ii) Average annual financial turnover during the last three years, ending 31st March of the previous financial year, should be at least Rs 1.81 Lacs. The proof of the same is to be submitted.
- iii) Bank Solvency: The firm should have sound financial capability and latest solvency certificate from Nationalized/ scheduled commercial bank for an amount not less than 3.63 Lacs. Bank solvency certificate should not be more than 12 months old.

- i) Those tenderers who consider themselves eligible for tender document can apply for registration by fulfilling the following requirement along with registration fee of Rs.1000/- plus 18% GST in cash or through demand draft in favour of AO/GGSSTP, PSPCL, Ropar. Request for registration shall be received in this office atleast 03 working days from the last date of sale of tender.
- ii) Documentary proofs as per PQR
- iii) Proof of PAN and Proof of GST registration number.
- iv) The registration of the firm will be done on merit on the basis of credentials of the firm and decision of CE, GGSSTP shall be final in this regard.

The request for registration by new firms must reach the office of registering authority at least one week before the bid opening date. Tender will be considered if the registration of the firm is done on or before the last date of bid submission.


All tenders must be accompanied by Earnest Money at the rates prescribed in the tender documents except in the case of those tenderers who are specifically exempted there under

#### 4. EARNEST MONEY:

- i) The firm shall be required to submit earnest money at the following rates in the form of Bank Draft along with the tenders.
    - a) Tender valuing up to Rs.50000/-: NIL
    - b) Tender valuing above Rs.50000/-: 2% of tender value rounded off to a multiple of Rs.10 on the higher side, subject to a minimum of Rs.5000/- and maximum of Rs.10 Lacs.
  - ii) The following shall be exempted from depositing earnest money:-  
Public Sector undertaking fully owned by the Punjab Govt. /other state Govts. Certificate of Govt. ownership issued by the concerned Government Department.
5. Earnest money shall be forfeited in case of withdrawal or modification of the offer within the validity period as required in the N.I.T./Tender specification after opening of tender.
  6. In case of successful tenderers, earnest money shall be converted into security deposit and short falls if any, shall be got deposited for faithfully execution of Work order/ contract.
  7. In case of tenderers whose tenders are not accepted, earnest money shall be refunded within 30 days of the award of order/contract to the successful tenderer.
  8. The tenderer will have to comply with all the rules and Regulations under Factory Act, Industrial disputes Act, Labour Laws, Bonus act and retrenchment compensation etc. on his appointment as contractor for the above said work at GGSSTP, Ropar.
  9. In case of due date of receipt/opening of tenders happens to be holiday; tenders shall be received and opened on the next working day at the time mentioned above.
  10. Tenders of firms who are black listed or with whom business dealings are suspended by PSPCL will be rejected.
  11. In case of any dispute regarding issue of tender documents or any other dispute, Chief Engineer/GGSSTP, Roopnagar shall be the final authority and no claim on this account shall be accepted.
  12. The PSPCL reserves its right to accept or reject any tender without assigning any reason.
  13. Tenders received without Earnest Money shall not be opened.

14. Firms which are registered with MSME are required to provide documentary evidence (Latest copy of memorandum of Micro Small & Medium Enterprises filed under section-8 of MSMED Act, 2006 duly acknowledged by competent authority.) of being a Micro, Small & Medium Enterprise. If the bidder does not submit the proof at the time of submission of its bid, it shall be considered as a large enterprise. A certificate for the last financial year, duly signed by any Director / Partner / Proprietor and Chartered Accountant that investment in Plant & Machinery of the enterprise does not exceed Rs. 25 Lac in case of micro and Rs. 5.00 Cr in case of small enterprise as prescribed in section 7 (1) a (i) & (ii) of the MSMED Act, 2006.
