These bids shall be submitted in two separate scaled envelopes duly subscribed on the envelope as PART-I and PART II. If bids are not submitted in this manner or Documents/EMD in Part I is incomplete as per Eligibility criteria, Price bid will not be opened and the tender bid will be rejected.
