#### TERMS AND CONDITIONS

- The work should be done strictly in accordance with PSPCL specification &
  Drawings/BIS Specifications /Pb. PWD specifications in that order of preference as well
  as to the entire satisfaction of the Engineer-in-charge and in case of any dispute on any
  point, the decision of Engineer-in-charge shall be final and legally binding on the
  contractor.
- In case specifications of any material are not clear it will either be according to relevant BIS/Pb. PWD Specifications and to the entire satisfaction of Engineer-in-charge.
- No compensation shall be paid in case of failure of Electricity and delay in the arrangement of the required material by the deptt.
- Addl. SE/Sr. Executive Engineer, Pilot workshop concerned shall act as Engineer-incharge for this work.
- Sufficient quantity of materials ma be arranged by the Contractor in advance to maintain the un-interrupted progress of work.
- All materials should be from sources approved by PSPCL and should conform to latest BIS standards with specifications/size as approved by Owner.
- 7. (i) Rates and prices should be written in ink and shall be entered both in figure and words. Where there is discrepancy between the rates quoted in figures and words rates quoted in words shall prevail and where there is a discrepancy between the amount worked on item rate by the department and amount entered by the tenderer the former shall governs.
  - (ii) The quoted rates shall include in statutory benefits payable to the workers by the contractor i.e. for weekly offs, overtime, insurance, Gazetted holidays, EPF, bonus and gratuity etc. as per labour laws.
- The monthly payments against the work done and measured shall be made by Senior Executive Engineer, (Engineer-in-Charge) through cheque.
- The contractor/his authorized representative will get the work checked from the Engineerin-charge or his representative.
- 10. The contractor shall submit along with his tender attested copies of his partnership deed showing the names and addressed of all partners of the firm and attested copy of his registration certificate with the Registrar for firms/societies shall also be submitted. Conditional tenders are liable to be rejected.
- Labour, T&P, material and supervision staff etc. of the contractor shall be subjected to check by PSPCL's security persons.
- 12. All letters sent to the contractor by registered post at the address given by him at the time of tendering shall be deemed to have been delivered to him in the natural course of time. To intimate the change in address, if any at any time, shall be the responsibility of the contractor.
- Income Tax as applicable will be deducted from all the payments released to the contractor.
- 14. GST is inclusive in the rates.
- 15. The tenderer shall have to make his own arrangement for the accommodation for his labour and stores during the execution of the work to the satisfaction of the Engineer-in-charge.
- 16. Time allowed for the completion of the work will be 1 year to be reckoned from the date on which the order to commence the work is given to the contractor.

#### Specific Terms and Conditions

- 3 Work at all times shall be open for inspection of the Engineer-in-Charge or his representative and higher authorities on their visit.
- 4 The contractor will make his own arrangements for storing his T & P etc required for the execution of the work.
- 5 Damage / loss to PSPCL property occurred due to negligence of the contractor or his staff shall be made good by the contractor at his cost within a reasonable period of time. The decision of the Engineer-in- Charge of PSPCL shall be final and binding.
- 6 The taxes such as Income tax and any other statuary deduction as per prevailing rules shall be deducted from the bill of the contractor.
- 7 In case of any dispute the decision of Sr. XEN / Civil, Pilot Workshop, Mohali shall be final and binding on the contractor.
- 8 The work shall be completed within a time period of ten days from the date of allotment order otherwise penalty shall be applicable as per PSPCL rules.
- 9 All the tenders must be accompanied by earnest money @ 2% of their quoted rates prescribed in the tender documents subject to minimum of Rs 5000/- except in the case of those tenderers who are specifically exempted there under.
