1. The firms may download tender specifications form PSPCL Website <https://pspcl.abcprocure.com> and send demand draft of Rs. 500/-+ GST@18% (Rupees Five Hundred plus GST@18%) in favour of Accounts Officer/O&M, GGSSTP, Roopnagar as cost of tender specification. It shall be clearly indicated on the envelope, that DD of cost of tender specifications is enclosed there in. Tenders of the firms, which do not submit the hard copy of the Demand draft(s) towards cost of specification before the last date and time of bid submission shall not be accepted.

2. **PREQUALIFYING REQUIREMENTS:-**

Tenders of only those firms/contractors will be considered who are registered with GGSSTP for the job of online setting of safety valves set pressure by treviteest method of 210 MW BHEL make units OR the contractor registered with NTPC/GHTP, Lehra Mohabbat and other such Central/ State Govt. Organizations will be considered eligible for participation, on submission of valid registration certificate subjected to the fulfilling the following PQRs:

- a) The bidder should have successfully executed / completed the contract of online setting of safety valves set pressure by treviteest method for units of 210 MW capacity during the last seven years ending last day of the month previous to the one in which applications are invited having minimum contract values as indicated below :-

- b) Firms minimum annual turn over should be Rs. 94,500/- during the last three financial years ending 31st March of previous financial year i.e. 2018-19.

3. **REQUIREMENT FOR REGISTRATION:-**

Those tenderers who consider themselves eligible can get themselves registered with GGSSTP by submitting the documents fulfilling the following requirements.


- a) The bidder should have successfully executed / completed the contract of online setting of safety valves set pressure by treviteest method for units of 210 MW capacity during the last seven years ending last day of the month previous to the one in which applications are invited having minimum contract values as indicated below :-
 - i) Three executed/ completed contracts, as above of cost including all taxes not less than Rs.47,250/- each. **OR**
 - ii) Two executed/ completed contracts, as above of cost including all taxes not less than Rs.56,700/- each. **OR**
 - iii) One execute/ complete contract, as above of cost including all taxes not less than Rs.94,500/- .
- b) The firm will submit completion certificate of executed work orders.
- c) Firms minimum annual turn over should be Rs. 94,500/- during the last three financial years ending 31st March of previous financial year i.e. 2018-19.



- d) **Bank Solvency:** The firm should have sound financial capability & should submit latest solvency certificate from a Nationalized Bank/Scheduled Commercial Bank for an amount not less than Rs. 1,89,000/-. Bank solvency certificate should not be more than 12 months old.
 - e) The safety valve testing system of the firm should be accepted by Central Boiler Board of India. The firm will submit the copy of approval.
 - f) Proof of independent EPF account number issued from Regional Provident Fund Commissioner/Assistant Provident Fund Commissioner.
 - g) The firm must not be a defaulter in the deposition of EPF. An Affidavit in original dully attested by an Executive Magistrate / Notary to the effect that the firm has not been defaulter in respect of deposition of EPF to the concerned EPF Commissioner for the workers deployed against work orders placed by PSPCL on it in the last five years. In case it is found defaulter at any stage, the contract shall be cancelled without any notice.
 - h) Proof of PAN and Proof of GST registration number with Punjab Govt..
 - i) Proof of having ESIC Code number.
 - j) The firm should not be black listed by any Govt. /Public Sector utility during the last five years. A self attested undertaking will be given by the bidder.
 - k) The firm will submit list of T&P and regular manpower.
 - l) The firm will deposit registration fee of Rs.1000 + GST@18%/- (Rs. One Thousand plus GST@18% only) in cash or through demand draft in favour of AO/GGSSTP, PSPCL, Ropar payable at Ropar.
 - m) The registration of the firm will be done on merit on the basis of credentials of the firm and decision of Chief Engineer /GGSSTP shall be final in this regard.
 - n) Tender will be considered if the registration of the firm is done on or before the last date of bid submission. The request for registration by new firms must reach the office of registering authority at least seven working days prior to last date of sale of tender document



4. All tenders must be accompanied by Earnest Money at the rates prescribed in the tender documents except in the case of those tenderers who are specifically exempted there from. Tenders of the bidders who do not submit the hard copy of the demand draft (s) towards earnest money shall not be opened.
5. The firm shall have independent EPF code Number issued from the concerned RPF authority. Sub code from the Office of Regional Provident Fund Commissioner, Chandigarh will be required.
6. The firm shall have to obtain Labour License under Contract Labour Regulation and Abolition Act, 1970 before undertaking the work and shall abide by various provisions/rules framed there under.
7. The contractor should have independent GST Registration no. with Punjab Govt. and will submit a copy of the same.
8. The firm shall follow the rules and regulations of Employee State Insurance Act, 1948.

- 1 Tenders of those tenderers who have purchased tender documents / Specifications shall only be opened and considered.
2. The tender must be valid for at-least 120 days from the date of opening of tenders.
- 3 Tenders received telegraphically, through e-mail, telex or fax shall not be accepted.
- 4 GGSSTP reserves the right to accept or reject any or all tenders without assigning any reason and no claim on this account shall be accepted.
5. Tenders received after the last date and time of receipt of tenders shall not be accepted. If the due date happened to be holiday, tenders shall be received and opened on next working day at the same time.
6. Tenderers shall specify clearly his rates as per Performa attached as Annexure-A.
- 7 Tenders received without Earnest money shall not be opened.
- 8 The firm shall have independent EPF code Number issued form the concerned RPF authority. Sub code from the Office of Regional Provident Fund Commissioner, Chandigarh will be required.
- 9 The contractor should have independent GST Registration no. with Punjab Govt. and will submit a copy of the same.

10. The firm shall follow the Rules and Regulations of Employees State Insurance Act, 1948. The firm is required to get itself registered with ESI. However in any case, the registration of the firm will be done but the firm will be required to submit its registration certificate with ESI before issue of Work order.
11. The firm shall have to obtain license under contract Labour Regulation and abolition Act, 1970 before undertaking the work and shall abide by various provisions/rules framed hereunder.
12. Firms must get register themselves as mentioned in terms & condition
13. **SOLVENCY CERTIFICATE:-** Every tenderer shall produce alongwith his tender a solvency certificate from a scheduled Bank. If he fails to produce such a certificate, his tender may not be considered.

15. Tender shall be submitted in duplicate. 17. The tenderers shall be required to submit fixed amount of earnest money of Rs.5,000/- in the form of Bank draft in favour of A.O./O&M, GGSSTP, Ropar as per Rules and Regulations of Board. Tenders of the bidders who do not submit the hard copy of the demand draft (s) towards earnest money shall not be opened.
