Eligibility Criteria 1. Registration:-

- a) Contractor/ L&C Society should be registered / enlisted for the execution of Civil Work with PSPCL, PSTCL, PWD, Railway, MES, NTPC, Central Govt. or other such organizations for works of Rs. 3.90 lacs & above on or before the due date of submission of tender.
