- Note: Only the manufacturers or their authorized dealers/representatives should be eligible to supply the material and manufacturer/supplier should have testing facilities at their works.
 - Notes:-1. (i) The firm must have GST Registration number & PAN No. and same should be provided while quoting the rates. If the firm is registered under 'Composite Levies' then the same should be clearly mentioned in the quotation.
 - The firm must provide HSN Code in price schedule Performa in Annexure' C'.

- Your quotation must be valid for at least 120 days from the date of opening. 8.
- Hand written/conditional quotation shall not be accepted. 9.
- All other terms and conditions of Annexure-B (attached) and PSEB/PSPCL Purchase 10. Regulations, 2017, amended upto date, shall be applicable.
- The firm should not be blacklisted by PSEB/PSPCL or any other Govt. Deptts./ 11. Organizations.
