

- 1) A set of tender documents containing detailed technical specifications, General instructions and terms & conditions can be obtained from Dy.CE/Headquarter, V&P.O. Ghanauli, GGSSTP, Ropar-140113 on payment of Rs.1000/- plus GST@18% by cash or demand draft drawn in favour of Accounts officer /O&M GGSSTP, Ropar payable at Ropar.
- 2) Tender of firms which do not purchase the tender documents in advance shall not be opened.
- 3) All tenders must be accompanied by earnest money at the rates prescribed in the tender documents except in the case of those tenderers who are specifically exempted there under.
- 4) Telegraphic / Fax/e-mail quotations shall not be accepted.
- 5) Negotiations shall not be held except with the lowest tenderer.
- 6) The perspective bidders are requested to visit the PSPCL website www.pspcl.in periodically even after purchasing the specifications from this office to check for corrigendum issued, if any. No corrigendum shall be published in newspaper.

Instructions for Tenderers

1. Tenders of those bidders who have purchased the tender documents/specifications shall only be opened.

2. **Pre-Qualification Requirement: -**

Pre-qualification requirement for registration and eligibility for this tender:-

- i) Tenders of only those technically suitable firm/contractor will be considered and opened who are registered with GGSSTP/GHTP/NTPC or other such central government organizations for the jobs of "**Rebabbiting of white metal bearings**" or similar type of jobs.
- ii) Annual Turn Over: Average annual financial turnover during the last three years, ending 31st March of the previous financial year, should be at least Rs 1.25 Lacs. Proof of the same has to be submitted.

The firm shall submit self-attested hard copies of proof of valid registration and other documents as per PQRs before the last date & time of applying for registration with GGSSTP. Their bid will only be considered if the documents submitted are found to be in order.

Those tenderers who consider themselves eligible (as per above PQR) for participation can get themselves registered with GGSSTP by submitting the attested copies of following documents along with non-refundable registration fee of Rs. 1,000/- (Rs. One thousand only) + 18% GST in cash receipt or through demand draft in favor of AO/GGSSTP, PSPCL, Ropar payable at Ropar:

- i) Documentary proofs as per PQR
- ii) Average annual financial turnover during the last three years, ending 31st March of the previous financial year, should be at least Rs 1.25 Lacs.
- iii) Proof of PAN and Proof of GST registration number.
- iv) An Affidavit in original dully attested by an Executive Magistrate/Notary to the effect that:
That the firm has not been black listed by any government/public sector undertaking during the last 5 years.
- v) The registration of the firm will be done on merit on the basis of credentials of the firm and decision of GM/CE, GGSSTP shall be final in this regard.

The request for registration by new firms must reach the office of registering authority at least one week before the bid opening date. Tender will be considered if the registration of the firm is done on or before the last date of bid submission.

4. Tender of firms, which have not purchased tender specifications in advance, shall not be opened.

5. All tenders must be accompanied by Earnest Money at the rates prescribed in the tender documents except in the case of those tenderers who are specifically exempted there under.

6. **EARNEST MONEY:**

5. All tenders must be accompanied by Earnest Money at the rates prescribed in the tender documents except in the case of those tenderers who are specifically exempted there under.
6. **EARNEST MONEY:**
 - i) The tenderers shall be required to submit Earnest money (EMD) of **Rs.5000/-** in the form of PSPCL Cash Receipt/Bank Draft in favour of AO/O&M GGSSTP, PSPCL Ropar (Payable at Ropar) along with the Tender as per Rules & Regulations of the PSPCL.
 - ii) The following shall be exempted from depositing earnest money:-
Public Sector undertaking fully owned by the Punjab Govt. /other state Govts. Certificate of Govt. ownership issued by the concerned Government Department shall be submitted in the envelope of Earnest money.
7. Tender shall be submitted in two separate envelopes one containing the tender documents and the other containing earnest money. The following words shall be super scribed on the envelopes containing tender and earnest money:-
 - a) "Envelope containing tender in duplicate against enquiry No. _____ for Repair of Bush Bearing of ID fan Motor and PA fan."
 - b) "Earnest money against tender enquiry No. _____"
8. Earnest money shall be forfeited in case of withdrawal or modification of the offer within the validity period as required in the N.I.T./Tender specification after opening of tender.
9. In case of successful tenderers, earnest money shall be converted into security deposit and short falls if any, shall be got deposited for faithfully execution of Work order/ contract.
10. In case of tenderers whose tenders are not accepted, earnest money shall be refunded within 30 days of the award of order/contract to the successful tenderer.
11. Incomplete or conditional or telegraphic tenders will not be accepted.
12. The tenderer will have to comply with all the rules and Regulations under Factory Act, Industrial disputes Act, Labour Laws, Bonus act and retrenchment compensation etc. on his appointment as contractor for the above said work at GGSSTP, Ropar.
13. In case of due date of receipt/opening of tenders happens to be holiday; tenders shall be received and opened on the next working day at the time mentioned above.
14. Tenders of contractors who are black listed or with whom business dealings are suspended by PSPCL will be rejected.
15. All tenders must be kept valid for 120 days from the date of opening of the tenders.
16. In case of any dispute regarding issue of tender documents or any other dispute, Chief Engineer/GGSSTP, Roopnagar shall be the final authority and no claim on this account shall be accepted.
17. The PSPCL reserves its right to accept or reject any tender without assigning any reason.
18. Tenders of the bidders who do not submit the hard copy of the demand drafts towards the Earnest Money shall not be opened.
19. Firms which are registered with MSME are required to provide documentary evidence (Latest copy of memorandum of Micro Small & Medium Enterprises filed under section-8 of MSMED Act, 2006 duly acknowledged by competent authority.) of being a Micro, Small & Medium Enterprise. If the bidder does not submit the proof at the time of submission of its bid, it shall be considered as a large enterprise. A certificate for the last financial year, duly signed by any Director / Partner / Proprietor and Chartered Accountant that investment in Plant & Machinery of the enterprise does not exceed Rs. 25 Lac in case of micro and
