Sub: LT surcharge/ HT or EHT rebate- Condition No.13 of General  
Conditions of Tariff and Tariff Schedules for LS, MS, NRS and  
DS categories of consumers.

In view of order of Hon'ble ATE, New Delhi dated 11.1.2012 and instructions issued vide Commercial Circular No. 18/2011 dt. 17-05-2011, the Condition No.13 of General Conditions of Tariff and relevant clauses of Tariff Schedules for LS,MS,NRS and DS categories of consumers issued vide CC 36/2006 (also Appendix to Section IV of ESIM, updated up to 31.3.11) have been updated/amended to be read as under:-

## Condition No.13- Voltage Surcharge/HT or EHT Rebate.

- i) DS/ NRS/ LS consumers catered at 400 volts against specified voltage of 11 kV shall be levied surcharge @ 15%.
- ii) DS/NRS/LS/BS consumers with Contract Demand exceeding 4000 kVA and all Arc Furnace consumers irrespective of quantum of Contract demand catered at 11 kV against specified voltage of 33/66 KV shall be levied surcharge @ 10%. However, surcharge @ 10% shall be applicable to LS consumers w.e.f. 1.4.2009 .
- iii) DS/ NRS/ BS/ LS consumers catered at 33/66 kV against specified voltage of 132/220 kV shall be levied surcharge @ 5%.
- iv) LS consumers (except Arc Furnaces) with Contract Demand exceeding 2500 kVA and upto 4000 KVA, catered at 11 kV against specified voltage of 33/66 kV shall be levied surcharge @ 7%. However, surcharge @ 7% shall be applicable to LS consumers w.e.f. 1.4.2009.
- v) All these surcharges will be leviable on the consumption charges including Demand Charges, if any or monthly minimum charges.
- vi) The exemptions from levy of surcharges as specified in the Conditions of Supply (para 5.2) shall continue as under:-

(a) Existing LS consumers availing supply at 66 KV but required to convert their system so as to receive supply at 132/ 220 kV will not

be levied any surcharge related to supply voltage, till such consumers request for enhancement of their Contract Demand.

(b) Existing DS/ NRS/BS consumers catered at a voltage lower than specified above, will be liable to pay surcharge only in case of any enhancement in Contract Demand.

(c) The PSPCL may effect supply at a lower voltage on payment of surcharge as specified/may be specified in the General Conditions of Tariff, if specified voltage for supply to an existing consumer for release of additional load/demand(total load/demand) is HT/EHT but there is a constraint in effecting supply at these voltages.

vii)

a) All categories of consumers (except Railway Traction) getting supply at higher voltage against the specified voltage as mentioned in Condition No.4/5 of the Conditions of Supply shall only be entitled to a rebate of 3% where supply is given at 33/66 KV and a rebate of 5% for supply at 132/220 KV. Such rebate is allowed on the consumption charges including demand charges, if any, or monthly minimum charges. However, no rebate is admissible for supply to Railway Traction as base supply voltage is 132KV/220KV.

b) Medium Supply, Small Power, Domestic Supply and Non-Residential Supply consumers are allowed a rebate of 7.5% on their consumption charges including demand charges, if any or monthly minimum charges where supply is catered at 11KV against the supply voltage of 400volts. Where supply is at higher voltages (11KV and above) rebate shall be allowed as per (a) above only if supply is given at higher voltage than the specified voltage mentioned in Clause No.4/5 of Conditions of Supply.

#### **NOTE:-**

All voltage rebates stand discontinued w.e.f 1<sup>st</sup> April 2010. The PSPCL will release all new connections or additional load/demand only at the specified voltage. The PSPCL will take steps to ensure that existing consumers getting supply at voltages lower than the specified voltage will be provided supply at the specified voltage. Until supply is converted to higher voltage applicable surcharge will continue to be levied as specified in General Conditions of Tariff. In case there are constraints in releasing a new connection and/or additional load/demand at the prescribed voltage or in converting the supply voltage of an existing consumer, the supply may be given/continued to be given at a lower voltage on the condition of payment of surcharge specified in General Conditions of Tariff.

All the existing consumers (As on 31.3.2010) getting supply at a higher voltage than that specified in Conditions of Supply will for the present be entitled to a rebate in Tariff at the prevailing rates.

## **2 SCHEDULE OF TARIFF FOR LARGE SUPPLY (S-1)**

### **Clause 3.4.3:-**

Consumers getting supply at 33/66KV shall get rebate of 3% and rebate of 5% for supply at 132/220KV. Rebate shall however be allowed only if supply is given at higher voltage against the specified

voltage mentioned in clause 4/5 of Conditions of Supply. The rebate shall be allowed on consumption charges including demand charges if any or monthly minimum charges.

**3. Schedule of tariff for Medium Industrial Supply (SII)**

**Clause 3.3**

The above tariff covers supply at 400 volts. A rebate of 7.5% on the consumption charges including demand charges if any or monthly minimum charges shall be allowed to consumers where supply is given at 11KV against the supply voltage of 400 volts.

**Clause 3.5**

In case of Rice shellers, Ice factories, Cold storages & Stone crushers falling under MS category the consumption shall be metered at 11 KV. The consumer shall be at liberty to install his own transformer. A rebate of 7.5% shall be allowed on the consumption charges including demand charges, if any or MMC (minimum monthly charges) provided transformer is installed by the consumer, otherwise rebate of 3% on consumption charges including demand charges, if any shall be allowed where transformer is installed by PSPCL at its cost.

**4. Schedule of tariff for NRS (SV)**


**Clause SV 3.2:-**

Rebate of 7.5% on consumption charges shall be allowed to the consumer, if supply is given at 11KV against specified voltage of 400 volts. For higher voltages (11KV and above) rebate shall be allowed as per condition No.13 of General Conditions of Supply, only if supply is given at higher voltage against specified voltage mentioned in Clause 4/5 of Conditions of Supply

**5. Schedule of tariff for Domestic Supply Schedule(SVI)**

**Clause SVI. 3.2:-**

Rebate of 7.5% on consumption charges or monthly minimum charges shall be allowed if supply is given at 11KV against specified voltage of 400 volts. For higher voltages (11 KV and above), rebate shall be allowed as per condition No.13 of General Conditions of Supply only if supply is given at higher voltage against specified voltage mentioned in Clause 4/5 of Conditions of Supply
