Sub: Levy of Electricity Duty on energy generated from captive power plants based on renewable energy sources.

Government of Punjab (Energy Branch) vide Notification No. 13/18/2004-PE5(1)/1558 dated 18.6.12 and endst.No.13/18/2004-PE5(1)/1561 dated 18.6.12 (copy enclosed) has approved the levy of electricity duty on the electricity generated by the captive power plants based on renewable energy sources located within the State of Punjab @ 13% ad-valorem, upon the owners of such captive power plants who intend to avail the benefit of renewable energy certificate scheme notified by the Central Electricity Regulatory Commission, New Delhi vide notification No.L-1/12/2010-CERC dated 29.9.2 10, after fulfilling the conditions which as such shall be imposed by the Chief Electrical Inspector, Punjab. The owner of the captive power plants based on renewable energy sources not intending to avail the benefit of the said scheme shall continue to avail the Electricity Duty Exemption benefit as granted vide notification No. 13/18/2004-PES(1)/1550 dated 25.5.2010.

The detailed Commercial Circular No.13/2012 issued be referred /appraised as regard to Renewable Purchase Obligations/ further as regard to Renewable Energy Certificates (RECs). Meticulous compliance of the above instructions may please be ensured.



In exercise of the powers conferred by sub-section(1) of Section 3 of the Punjab Electricity (Duty) Act, 2005 and all other powers enabling him in this behalf, the Governor of Punjab is pleased to levy with immediate effect the Electricity Duty on the electricity generated by the Captive Power Plants based on renewable energy sources located within the State of Punjab at the rate of thirteen percent ad-valorem, upon the owners of such Captive Power Plants, who intend to avail the benefit of Renewable Energy Certificate Scheme notified by the Central Electricity Regulatory Commission, New Delhi, vide Notification No. L-1/12/2010-CERC, dated 29<sup>th</sup> September, 2010, after fulfilling the conditions which shall be imposed by the Chief Electrical Inspector, Punjab. The owners of the Captive Power Plants based on renewable energy sources not intending to avail the benefit of the said scheme shall continue to avail the benefit as granted by notification No. 13/18/2004-PE5(1)/1550 dated 25.5.2010. //

He will assess and generate bill of electricity duty to the said firm. He will also ensure that the realized Electricity Duty is deposited in the Punjab State Treasury in the Head of Account:-

"0043 - Taxes & Duties on Electricity

101 - Taxes on consumption and sales of Electricity"

and the original challan is submitted to the office of Chief Electrical Inspector by the 15th of following month.
