APPENDIX 'A'

RULES FOR DEPARTMENTAL ACCOUNTS EXAMINATION FOR ENGINEERING SUBORDINATES.

...

SHORT TITLE AND COMMENCEMENT.

- i) These rules may be called "Punjab State Electricity Board Rules for the Departmental Accounts Examination for Engineering Subordinates".
- ii) These rules will come into force with immediate effect.

SECRET

- a) All the existing Junior Engineers are required to pass the examination by Jan., 1980 failing which their next increment will not be released.
- b) Engineering Subordinates who are to be promoted as Junior Engineers in terms of Office Order No.469/ENQ-G-298 dt.13.7.78 may be promoted as such subject to the condition that they will be required to pass the said examination by Jan '1980 failing which their next increment will be stopped.
- c) The Engineering Subordinates who are to be promoted after Jan'1980 will not be promoted as Junior Engineers unless they pass the said examination.
- d) New recruits will have to qualify the examination within three years from the date of their respective appointment/promotion. They shall also be allowed to re-appear in the examination even after the expiry of three years period of service subject to the condition that their third increment falling due on completion of three years service shall only be allowed retrospectively if they pass the examination in six chances (whether availed or not). The examination held within six months of the date of their appointment/promotion will, however, not be counted towards six chances referred to herein.
- e) All temporary/officiating Engineering Subordinates shall have to pass the examination before they are considered for confirmation in their post.
- f) Sectional Officers (Civil) will, however, be required to qualify the examination in two papers only, excluding the paper on Revenue Accounts & Sales.

Note:- i) The term "Engineering Subordinates" shall mean Technical Subordinates as Line Supts., Sub Station Operators, Tech.Asstts., Sectional Officers (Civil) and Control Room Operators etc.

- ii) The time limit for passing the examination will be relaxed/extended in very exceptional circumstances where it is established that the failures were due to the reasons or circumstances beyond control of the subordinate concerned.
- iii) The Engineering Subordinates who have passed the Departmental Accounts Examination for Engineer Officers are exempted from appearing in this examination.

3. SUBJECT AND PASS PERCENTAGE

- i) The subject of the examination will be as per Annexure 'A'. Any change in the syllabus, in future, will be effected by the Secretary with the approval of the A. & F.M.
- ii) Each candidate will have to obtain 40% of the full marks of each paper assigned to it to pass the same. Grace marks upto five will be allowed only in case the candidate appears in all the papers and is short of pass marks to that extent in a paper.

iii) The candidate who secures 50% marks in a paper will pass from that paper. In the remaining papers or a paper, 40% marks will be required.

4. DATE AND PLACE OF THE EXAMINATION

The examination shall be conducted twice a year by the Secretary at a place or places and the time to be notified by him. The applications will be received by the Examination Branch upto the date notified and Roll Nos. issued to the eligible candidates 15 days before the commencement of the examination.

5. TRAVELLING ALLOWANCE.

The candidates will have to appear at the centre, if there is any, at the place of their duty otherwise at the centre nearest to the place of their duty. They will be entitled to Travelling Allowance under Rule 36 of the FSSB, M.S.R.Vol.III.

6. CONDUCT OF THE EXAMINATION:

a) The question papers will be set and answer books evaluated by the officers nominated by the Secretary with the approval of A.F.M. and examination conducted under his supervision/instructions. The result will be declared by the Secretary with the approval of the A.F.M. and no appeal shall lie against the result so declared. The failed candidates will be issued individually a list of marks obtained by them.

b) Standard of the Papers: The examination is purely elementary and its standard would be quite low as compared to that of Engineer Officers.

7. UNFAIR MEANS:

i) The candidates are to attempt the papers without reference to any book/notes etc. Any candidate found in possession of Books/Notes/Charts etc. concerning the subject or using any sort of unfair means, will be expelled from the examination hall immediately. He will not be allowed to attempt the remaining paper/s and disqualified in the examination besides being debarred from appearing in the next session and issued a letter of warning with a copy to be placed in his Q.R.file.

ii) The candidates leaving peculiar marks in their answer book so as to identify the same or violating any instruction regarding the conduct of the examination and/or causing indiscipline will be disqualified if concerned paper besides being warned.

8. RE-CHECKING OF PAPER.

The failed candidates may apply for re-checking of paper/- by depositing a sum of Rs.50/- per paper, within one month of the declaration of the result. The re-checking will be done to see that the totals of the marks awarded by the Examiner are correct, and no question or part thereof has remained un-evaluated. The re-checking is not intended for re-evaluating the answer book. The fee of Rs.50/- will be refunded in case any discrepancy is notified and if the status-quo is maintained, the fee so deposited shall be forfeited.

9. AMENDMENT TO THE REGULATIONS:

No change shall be made by any authority in these regulations except by the Board. The Secretary may, however, effect minor changes in the syllabus with the approval of the A.F.M. As regards any doubt to the interpretation of these regulations, the clarification issued by the Secretary shall be final.

Continuation this office Memo.No.29782/30731/DAE/ES-10/79 dated 2.7.79 vide which syllabus/regulations for the subject cited examination were circulated.

2.- The Punjab State Electricity Board, in its 310th meeting held at Patiala decided to amend the existing (a), (b), (c) & (d) clauses of Para 2 under heading "Scope" of the Regulations for the Departmental Accounts Examination for Engineering Subordinates with the following ones, in order to provide more chances to negotiate the examination for Junior Engineers and other Engineering Subordinates so that they may not be held up at the increment/promotion as per the provisions of the existing regulations, after January, 1980:-

- a) All the existing Junior Engineers are required to pass the said examination within six chances (whether availed or not) from the date of introduction of this examination failing which their next increment will not be released.
- b) The I.A.s Supdts. and Engineering Subordinates who are eligible for promotion as Junior Engineers upto six chances from the date of introduction of this examination may be promoted as such, subject to the condition that they will have to pass the said examination within six chances (whether availed or not), failing which their next increment will not be released.

- c) The Line Supts. and Engineering Subordinates who are due for promotion after the expiry of six chances (whether availed or not) will not be promoted as Junior Engineers unless they pass the said examination.
- d) All other Engineering Subordinates including new recruits will have to qualify the examination within six chances from the date of their respective appointment/promotion, failing which their next increment will not be released.
- e) All the Junior Engineers & Engineering Subordinates who fail to qualify the examination within six chances will, however, be allowed to re-appear in the examn. even after the expiry of six chances, but the with-  
increment/s will only be released retrospectively, without payment of arrears, on their passing the examination.

Note:- The examination held within six months of the date of appointment/promotion as Engineering Subordinate will not be counted as a chance.

Other conditions of the regulations ibid shall remain unchanged. The existing paras (e) & (f) may be read as (f) & (g).



2.- The Punjab State Electricity Board, in its 7/83 meeting held on 5.5.1983 at Chandigarh, has decided that:-

- a) Examinations for Engineering Sub-ordinates held in 10/79 & 1/80 may not be counted towards six attempts admissible as the examination was new and any disability incurred on account of counting of attempts in the examination amongst the attempts in the matter of pay fixation may be undone without payment of arrears.
- b) An exemption clause, as under, may be added to the rules governing Departmental Accounts Examination for Engineering...

Sub-ordinates:-

The Member-in-charge may grant exemption to any member of the service from passing the Departmental Accounts Examination for Engineering Sub-ordinates. The grant of exemption may be considered in extremely hard cases on the following considerations:-

- (i) The official making the request has attained the age of 50 years.
- (ii) The record of the official is consistently good and without blemish.
- (iii) The official has atleast made six attempts to clear the examination.

Once exemption has been granted to an official no disability, whatsoever shall attach to him in order to consider him for further promotions".

I. PSEB SAS (Examination) Regulations, 1970.

Regulation 4. (Pass Marks).

1. A candidate who obtains 40% or more marks in any paper in any attempt will be declared pass in that paper.
2. Candidates who pass one or more papers in any attempt will not be required to appear again in those papers and will appear in the remaining paper/s only in subsequent attempts.
3. A candidate will be declared pass in the examination as-a-whole when he clears all papers of the particular part in one or more attempts.
4. Grace marks upto five will be allowed to a candidate who appears in one attempt in all the four papers but passes in three papers and is short of marks upto that extent in one paper. No grace marks will be allowed in other cases.

II. PSEB Rules for Departmental Accounts Examination for Engineering Subordinates.

Regulation 3(ii) & (iii) - (Subject & Pass Percentage).

- 3(ii) A candidate who obtains 40% or more marks in any paper in any attempt will be declared pass in that paper and will appear in the remaining paper only in subsequent attempts.
- 3(iii) Grace marks upto five will be allowed to a candidate who appears in one attempt in both the papers and is short of marks upto that extent in one paper. No grace marks will be allowed in other cases.

III. Public Engineer Officers Departmental Examination Regulations, 1952

Regulation No. 10 (Pass Percentage)

- i) A candidate who obtains 40% marks in any paper in any attempt will be declared pass in that paper.

For uniform implementation of this decision for Engineer Officers, Ministerial Establishment and Engineering Subordinates, the following procedure may hence-forth be followed in this behalf :-

i) Failure to pass the Departmental Accounts Examinations (presently within prescribed chances/period) will not deter the members of the service to get their normal increments/S.S.

ii) Passing of the Departmental Accounts Examination will be a pre-requisite condition for promotion to the next higher post.

The Punjab State Elec.Board is pleased to order that henceforth the category of Drawing Estt: shall be classified as Engineering (Technical) Subordinates and the passing of the Departmental Accounts Examination of Engineering Subordinates shall be mandatory for them for further promotion as Asstt. Engineer(Elect. or Civil), as the case may be, in terms of various provisions of PSEB Service of Engineers (Elect) Regulations, 1965 and PSEB Service of Engineers(Civil) Regulations, 1965. To implement the decision of the Board, the amendments in Departmental Accounts(Bran.)Rules/Regulations for Enngg: Subordinates PSEB Service of Engineers(Elect) and (Civil) Regulations 1965 are hereby ordered, as follows, with immediate effect:

1. PSEB Depts. A/cs(Examination) Rules for Enngg.Subordinates:

i) Rule 1(i)(a):

The following sub-para is added under Rule 1(i)(a) of the Rules mentioned *ibid*, which shall form part of this Rule:

The members of Drawing Establishment(not below the rank of Draftsman) shall also not be considered for promotion as AE/Electrical unless they have passed the DAE prescribed for Engineering Subordinates.

ii) Rule 2(ii)(c):

The following sub-para is added under Rule 2(ii)(c) of the Rules mentioned *ibid*, which shall form part of this Rule:

The members of Drawing Establishment(not below the rank of Draftsman) shall also not be considered for promotion as AE/Civil unless, they have passed the DAE prescribed for Engineering Subordinates(Civil).

Provido under Rule 2:

- 1) The members of Drawing Estt. whose names are immediately under consideration for promotion as AE under different provisions of PSEB Service of Engineers(Elect) and (Civil) Regulations, 1965, shall have 4 chances in the next 4 sessions to clear the Examination and their promotion in that case shall be provisional. In case, they pass the examination within 4 chances in the next 4 sessions from the date of issue of this amendment, they shall be allowed the regular scale of AE from the date they assumed the charge of the post of AE. In case, they could not do so, grant of regular scale shall be deferred by the time taken extra by them in clearing the examination beyond 4 chances.
- ii) The members of Drawing Estt. whose names may subsequently become due, but within the specified period of 4 chances in next 4 sessions of holding the Exam-

ination, shall have only remaining no. of chances to clear the exam., in the sessions held immediately thereafter. The grant of regular scale to them shall also be deferred by the time taken extra by them in clearing the exam. beyond admissible no. of chances.

- 111) After the lapse of 4 chances (i.e. 4 sessions from the date of issue of amendment), the promotion of members drawing estt; shall be considered like JEs and other Engg;Subordinates(Tech).

II) PSES Service of Engineers(Elect.)Regulations,1965:

- 1) The category of Draftsman is added at Sr.No.11 under Tech.Subs.(Gr.II) of Appendix-E appended with the Regulations mentioned ibid.
- 2) The categories of Divisional Head Draftsman(DHD) and Circle Head Draftsman(CHD) are added at Sr.No. 7 & 8 under Tech.Subs.(Gr.I) of Appendix-E, appended with the Regulations mentioned ibid.

III) PSES Service of Engineers(Civil)Regulations,1965:

2(a) The junior Engineers (Grade-I and-II) and Engineering Subordinates shall not be considered for promotion unless they have passed the Departmental Accounts Examination prescribed for Engineering Subordinates. On passing the Examination and, on promotion, they shall rank junior to all those who have been promoted earlier to them.

The Members of Drawing Estt. (Not below the rank of draftsman) shall also not be considered for promotion as A.E./Electrical unless they have passed the D.A.E prescribed for Engineering subordinates.

2(b) No Change.

2(c) AE-II/Civil will, however, be required to qualify the Examination in One paper only excluding the paper on Revenue Accounts and Sales.

The Members of Drawing Estt. (Not below the rank of draftsman) shall also not be considered for promotion as AE/Civil unless they have passed the DAE prescribed for Engineering Subordinates (Civil).

Proviso under Rule 2:

1) The members of Drawing Estt. whose names are immediately under consideration for promotion as AE under different provisions of PSEB Service of Engineers (Elect) and (Civil) Regulations, 1965, shall have 4 chances in the next 4 sessions to clear the Examination and their promotion in that case shall be provisional. In case, they pass the examination within 4 chances in the next 4 sessions from the date of issue of this Amendment, they shall be allowed the regular scale of AE from the date they assumed the charge of the post of A.E. In case, they could not do so, grant of regular scale shall be deferred by the time taken extra by them in clearing the examination beyond 4 chances.
