- 1) **OFFLINE MODE:** Pensioners residing at place other than DDO living in india may get life certificate attested by Manager of residing bank .
- 2) **FOR NRI's:** Pensioners living abroad can get it attested by Notary Public/ High Commission and same may be uploaded in your respective employee ID's.
