

1. For issue of tender documents:-

Tenders to only those firms will be issued who are authorized/approved by state/central govt. department to carry out Safety Audit or having experience of safety audit of govt. utilities amount equal to or more than Rs. One lac and shall submit copy as proof of such authorization/experience with the request to the O/o Addl SE/Fire & Safety GGSSTP Roopnagar and further subject to following criteria.

- i) Average Annual financial turnover during last three year ending 31st March of the previous year should be at least eighty thousand approx.
- ii) Experience of having successfully completed work of Safety audit for units of 110 MW capacity or above during last seven year ending last day of month previous to the one in which application are invited should be the either of the following :-
 - a. Three completed works costing not less then amount equal to Fifty thousand each. Or
 - b. Two completed works costing not less then amount equal to Sixty thousand each. Or
 - c. One completed works costing not less then amount equal to One lac each.



2. RATES: The rates quoted must be firm. The tender must be valid for at least 120 days from the date of opening of tenders. GST as applicable shall be paid additionally.
3. Tenders received telegraphically, through e-mail, telex or fax shall not be accepted.
4. GGSSTP reserves the right to accept or reject any or all tenders without assigning any reason and no claim on this account shall be accepted.
5. Tenders received after the last date and time of opening of tender shall not be accepted. In case, the due date of opening tenders happens to be a holiday, the tenders shall be received and opened on the next working day at the same time and place.
6. The tenderers shall clearly type his rates as per Performa attached as Section-III.
