Installation of distribution transformers, erection of HT/LT lines, works related with the system improvement, release of new connection of GSC, Industrial, Tube well etc., deposit works (capital), works of meter shifting in Pillar boxes outside the consumer premises and emergent erection work of damage lines, pole and transformers resulting natural calamities during the year 2015-16 as per approved labour rate of PSPCL under variour DS Divisions (City Pathankot, Suburban Pathankot, Gurdaspur, Dhariwal, Qadian, City Batala & Suburban Batala) under Gurdaspur Circle.

Pre-qualification conditions for outsourcing of labour component for carrying out works would be:

1. Contractor must possess a valid license of 'A' category contractors (Electrical) up to 31-3-16 issued by the Chief Electrical Inspector Punjab under Indian Electricity Rule-1956 clause 45 for carrying out such type of jobs.
2. Contractor will supply the copy of running EPF registration No./Labour license/exemption certificate from labour Department.
3. The Contractor must have PAN NO. (PAN No. to be submitted).
4. The Registration fee Rs. 1000/- Non-refundable to be deposited through State Bank of Patiala. Bank draft in favour of PSPCL payable at Gurdaspur.
5. The contractor must possess running Service Tax Registration No. issued by concerned department under the Service Tax Act.
6. The contractor shall supply the experience certificate regarding successful execution of electrical works.
7. The contractor shall supply the bank solvency from the scheduled bank.
8. Fulfilling the required formalities by the contractor does not mean a grantee for enlistment/empanelment if he fails to comply with the other conditions of NIT.
9. The registration authority reserves the rights to reject the registration of any contractor at any stage without any notice/reason if his documents and his work and conduct found unsatisfactory. In case any dispute arises The Chief Engineer /op. Border Zone, Amritsar will be the final authority.
10. This registration shall be valid for the financial year 2015-16 and same can be extended following standing instructions as per the further requirement of the PSPCL.
