1. Laying of pipeline

- a) Lay-out of pipe line having size 250mm & 200mm dia including underground/over-ground erection as decided by Engineer-in-charge shall be in scope of contractor.
- b) For any underground pipeline, firm will back fill the area after completion of work & make its surface same as before digging (or as desired by engineer incharge).
- c) Laying of 204 mtr 250mm dia pipeline and 146 mtr 200 mm dia pipeline along with associated auxiliary like valves, NRV etc and making any header will be in scope of contractor.
- d) If required pipeline shall be supported by cast-in-situ concrete blocks, as decided by Engineer-in-charge. Each block shall not be distant more than 15 mtr from each other. Pipeline shall be properly engaged with these blocks with Steel support/clamps.
- e) Pipe line after complete erection or during the works (as desired on the discretion of Engineer in Charge) can be hydro tested (all arrangements has to be done by the firm) at pressure (as decided by engineer in charge) as per pipeline requirement.
- f) Length of pipeline can be decreased subject to site requirement. Payment to firm/contractor shall be made as per actual length laid.
- g) Joining of pipe line by welding double layer will be done after making "V" with grinder.
- h) Marking on each line (Overhead/over-ground) showing direction/flow and Description of pipe line is to be done clearly.
- In case, any new support is required for holding pipeline due to any change in the route, the same has to be provided and the support structure will also be erected & also to be painted after providing a layer of Antirust primer. (Material for support structure will be provided by PSPCL).
- j) The length of pipeline includes portions occupied by accessories such as valves, flanges, sockets, bends, tee-joints etc. to be erected.
- k) One coat of Antirust primer & two coat of red paint (1st Class) on pipeline surface and supporting Steel structure after thorough cleaning with emery paper & cloth (as per IS) will be in scope of contractor. The paint should be of Nerolac/Berger/Asian make only.
- Any dismantlement, if required, shall be in scope of contractor Contractor will arrange its own tractor-trolley to shift dismantled material from site to GGSSTP main store.
- 2. Any other work required for completion of the job as decided by Engineer-in-charge will be in the scope of the firm.


