I. <u>Registration:-</u> Contractor/L&C society should be registered / enlisted for the execution of Civil Works with PSPCL, PSTCL, PWD, Railway, MES, NTPC, Central Govt. or other such organizations for works of of ₹ 2.40 lacs & above on or before the due date for uploading the tenders.
