**TERMS & CONDITIONS**

1. A set of tender documents containing terms and conditions, technical specifications and scope of work, can be obtained from office of DY. CHIEF ENGINEER / Hq., GGSSTP, Roopnagar-140113 by remitting its cost(non-refundable) of Rs 1000/- + GST@18%( Rs. One Thousand Plus GST@ 18 % ) through demand draft in favour of AO/O&M, GGSSTP, PSPCL, Roopnagar payable at Roopnagar. Tenders of the firms who do not purchase the tender documents in advance shall not be opened.

2. **PREQUALIFYING REQUIREMENTS:-**

Tenders of only those firms/contractors will be considered who are registered with GGSSTP for Annual overhauling of Boiler , Airpreheaters and its auxiliaries Or the contractor registered with NTPC/ GHTP, Lehra Mohabbat and other such central/ State Govt. organizations will be considered eligible for participation on submission of valid registration certificate subjected to fulfilling of following PQR's:

- a) The bidder should have proof of having successfully completed/ being executed " Overhauling jobs" AND/OR "Erection, Testing & commissioning job" of Air Pre-Heaters etc. on 110MW or higher capacity thermal units during the last

seven years ending on 31.03.2026 having minimum contract value of either of following :-

- i. Single, completed/ being executed work order covering at least main equipment i.e. Air-Preheaters etc. costing (including all taxes) not less than **Rs. 91,000/-**. **OR**
- ii. Two, completed/ being executed, work orders, from which at least one work order shall be covering main equipment i.e. Air-Preheaters detailed as above each costing (including all taxes) not less than **Rs. 54,600/-**. **OR**
- iii. Three, completed/ being executed, work orders, from which at least one work order shall be covering main equipment i.e. Air-Preheaters etc. detailed as above each costing (including all taxes) not less than **Rs. 45,500/-**.

Notes:

1. Work Order value shall be considered on one year basis
2. In case work order period falls beyond the seven year period then proportional amount of work order value will be considered as executed work, against the work order.
3. Completion certificate is must against each completed work order, placed on firm other than PSPCL.
4. In case work order(s) is/are under execution as on date of 31.03.2026 the value of work completed till 31.03.2026, will be considered provided the value of executed work is certified by the work order issuing authority.

Firms already registered with GGSSTP/GHTP/ NTPC or other such Central/ State govt. organizations shall have to fulfill PQRs, all clauses of the NIT/ Tender specifications of the tender and shall submit self-attested hard copies of proof of valid registration along with other documents for further participation in the tender. Their participation in the tender will only be considered if the documents submitted are found in order.

3. **Requirement for new Registration:** - Those tenderers who consider themselves eligible for tender documents can get themselves registered with GGSSTP by submitting the documents fulfilling the following requirements.

a) The bidder should have proof of having successfully completed/ being executed " Overhauling jobs" AND/OR "Erection, Testing & commissioning job" of Air Pre-Heaters etc. on 110 MW or higher capacity thermal units during the last seven years ending on 31.03.2026 having minimum contract value of either of following :-

- i. Single, completed/ being executed work order covering at least main equipment i.e. Air-Preheaters etc. costing (including all taxes) not less than **Rs. 91,000/-** **OR**
- ii. Two, completed/ being executed, work orders, from which at least one work order shall be covering main equipment i.e. Air-Preheaters etc. detailed as above each costing (including all taxes) not less than **Rs. 54,600/-**. **OR**
- iii. Three, completed/ being executed, work orders, from which at least one work order shall be covering main equipment i.e. Air-Preheaters etc. detailed as above each costing (including all taxes) not less than **Rs. 45,500/-**.

b) Firms average annual turnover should be at least Rs. 91,000/- during the last three financial years ending 31<sup>st</sup> March of previous financial year. Audited balance sheet for last three financial years may be submitted.

c) **Bank Solvency:** The firm should have sound financial capability & should submit latest solvency certificate from a Nationalized Bank/Scheduled Commercial Bank for an amount not less than Rs. 1.82 Lakh, Bank solvency certificate should not be more than 12 months old.

d) Proof of independent EPF account number issued from Regional Provident Fund Commissioner/Assistant Provident Fund Commissioner.

e) The firm must not be a defaulter in the deposition of EPF. An Affidavit in original dully attested by an Executive Magistrate/Notary to the effect that the firm has not been defaulter in respect of deposition of EPF to the concerned EPF Commissioner for the workers deployed against work orders placed by PSPCL on it in the last five years. In case it is found defaulter at any stage, the contract shall be cancelled without any notice.

f) Proof of PAN and Proof of GST registration number with Punjab Govt.

g) Proof of having ESIC Code number.

h) The firm should not be black listed by any Govt. /Public Sector utility during the last five years. A self attested undertaking will be given by the bidder.

i) The firm will submit list of T&P and regular manpower.

- j) The firm will deposit registration fee of Rs.1000/-+ GST @18%(Rs. One Thousand plus GST@18%) in cash or through demand draft in favour of AO/GGSSTP, PSPCL, Roopnagar payable at Roopnagar.
- k) The registration of the firm will be done on merit on the basis of credentials of the firm and decision of Chief Engineer/GGSSTP shall be final in this regard.
- l) Tender will be considered if the registration of the firm is done on or before the last date of bid submission. The request for registration by new firms must reach the office of registering authority at least five working days prior to last date of sale of tender document.**
4. All tenders must be accompanied by Earnest Money at the rates prescribed in the tender documents except in the case of those tenderers who are specifically exempted there from. Tenders of the bidders who do not submit the hard copy of the demand draft (s) towards earnest money shall not be opened.
  5. The firm shall have independent EPF code Number issued from the concerned RPF authority. Sub code from the Office of Regional Provident Fund Commissioner, Chandigarh will be required.
  6. The firm shall have to obtain Labour License under Contract Labour Regulation and Abolition Act, 1970 before undertaking the work (if required) and shall abide by various provisions/rules framed there under.
  7. The contractor should have independent GST Registration no. and will submit a copy of the same.
  8. The firm shall follow the rules and regulations of Employee State Insurance Act, 1948.
  9. CE/ GGSSTP, Roopnagar reserves the right to refuse issue of tender documents to any contractor/firm without assigning any reason and also to reject any or all offers without assigning any reason and no claim on this account will be accepted.
  10. Tender received through telegraph, telex, fax or e-mail shall not be considered at all.
