## 1.0 Minimum Pre-Qualification Criteria

The bidder should be approved/recognized Institute/Lab from Central/Punjab Pollution

2.0 The tender documents shall be issued to the firms only who will submit certificate of reorganization of their Institute/Lab from Central/Punjab Pollution Control Board along with the bid.

### 3.0 Earnest Money Deposit

Earnest money @2% above the Rs.50,000/- of tender amount subject to minimum Rs.5000/-

4.0 <u>GST</u>

Bidder must have valid GST registration number of State of Punjab. GST, as applicable, will be paid as per prevailing provisions of GST Act & laws against submission of documentary proof at rate(s) prevailing during the contracted delivery period on the basis of actual. The following certificates shall have to furnish along with the invoice-cum-gate pass duly signed by the authorized agent/signatory.
