

Acid Storage Tank



SCOPE OF WORK

Subject: Modification/Repair, Fitting and Rubber lining of Acid Storage Tank GGSSTP Roopnagar

- Firm will modify/fabricate the old tank as per drawing placed at Annexure-I.
 Technical specifications of tank to be rubber lined after
 modification/fabrication are placed at Annexure-II. Welding/machining/
 re-conditioning work shall also be in firm's scope.
- Preparation of surface by sand blasting/burning/chipping and rubber lining in Acid Injection Tank as per IS:4682 Part-I.
- Transportation of Tank, if required, will be in firm's scope.
- The rubber sheets, welding electrode, cutting gas, nut-bolt and all other consumables/non-consumable material required for the entire job will be arranged by the firm
- The firm will arrange all the T&P required for work.
- The firm will arrange for spark testing to check continuity of rubber lining as per IS: 4682 Part-I.
- The firm will arrange for hardness testing of rubber lining as per tender specifications.
- After clearance and through checking by Engineer-in-charge firm will properly fit/install newly fabricated/modified tank at DM Plant Stage-II as decided by Engineer-in-charge.
- In case during fitting of Acid storage tank any damage is made to foundation, then firm will set right it as per actual with no extra cost.
- During fitting of Acid storage tank if any extra support/ modification/packing is required for foundation where the tank will rest, then firm will provide the same with no extra cost.
- Any other work required for completion of the job as decided by Engineer-in The thicks and the scope of the firm.
- The thickness of rubber lining will be 5 mm (2.5 mm x 2 layers) in case of

Scope of Supply by Contractor

The firm shall arrange its own tools & tackles/T&P required for cutting, grinding welding set & welding lead etc., lowering and lifting/shifting of Tank. A)
