 - The Society should be registered with Registrar Co-op Societies Punjab (B)
 - The L/C Co-op Societies should be enlisted with Punjab PWD (B&R), MES, Irrigation Deptt. or any other (C) Govt. Deptt.
 - The societies/contractors should posses:-(D)
 - PAN No. is essential (i)
 - GST No. is essential (ii)
- The Contractors should have registered with Pb. Govt./Central Govt. Deptt. such as PSPCL/PSTCL, PWD Pb., Pb. IB, MES,CPWD, Railway etc. (essential) for appropriate class/financial limit. 2.
