- 1.4 The timing of serving are subject to change with one day advance notice.
- 1.5 The items of food & beverages to be provided/served by the contractor will be as per our Enquiry documents.
- 1.6 The brands of material/ items to be used in cooking and catering will be of best quality as per the relevant standards of Health Dep't. etc., if any accident/miss-happening occurred due to non-hygienic meals, the responsibility will be of the contractor.
 - The contractor shall be paid for the persons actually availing the catering facilities on a particular day/meal. The contractor shall not be paid catering charges in respect of participants who are absent from any meal on a particular day provided notice is given at the beginning of the same day (i.e. breakfast time in the register to be maintained with the Manager (Hostel)/ Catering supervisor.
- 1.8 The items of catering services will be as per details of our said Enquiry document. The PSPCL reserves the right to alter/ modify the menu by giving 1 (one) day intimation to the contractor.
- 1.9 The PSPCL shall have full right and shall be at liberty to refuse or deny the servicing of any items in the food or beverages.
- 1.10 The PSPCL shall have full right to terminate the contract without assigning any reason by issuing 24 hrs. Prior notice.
- 1.11 In case the contractor or any of his employee fails to fulfill his obligation for any day or any number of days to the satisfaction of the PSPCL, for any reason whatsoever, he shall pay to the PSPCL by the way of liquidated damages @ Rs. 50/- per participant per day.
- 1.12 The contractor shall engage the services of sufficient number of able, trained, efficient, neat, healthy, honest, well behaved and skilled persons for cooking and serving of meal/food. The
- attendants/ waiters/cooks should be properly trained and should wear smart and neat uniform, with their name badges.
- 1.13. The contractor must engage appropriate number of trained cook/cooks for providing authentic North Indian dishes. The contractor shall provide proper uniform to his staff at his own cost. The contractor will be responsible for good conduct and performance on their part and the contractor shall be deemed for all legal and contractual purposes as/ to be their employer of the said persons and such persons will not have any claim for any employment in the PSPCL now or any future date.
- 1.14 The contractor shall be responsible for meticulous compliance of provisions of the Contract Labour (Regulation & Abolition) Act, 1970 and submission of various returns under the relevant rules framed under the above Act.
- 1.15 The contractor shall arrange all the raw materials including control items including cooking gas/fuel etc at his own cost.
- 1.16 The contractor will start the services in the month of APRIL 2023.
- 1.17 The contractor shall bear all the taxes, rates, charges, levies or claims whatsoever as may be imposed by Central/State Govt./Local Body or Authority.
- 1.18 The contract for catering service will be started from APRIL 2023 unless the provision

at 1.10 above is invoked. If during the prevalence of the contract, any Govt. Notification prohibits employment of Contract Labour for catering services, the contract shall come to an end forthwith and no compensation shall be paid to the contractor,

1.19 The contractor shall be liable to comply with all the rules and regulation in respect of all the labour laws and statutory requirements, including fire safety regulations and other regulations, which are in vogue or will become applicable in future.

1.20 The contractor shall accept and bear frill and exclusive liability for the payment of any or all taxes etc., now in force or hereafter imposed, increased and/or revised from time to time by Central or State Govt, or by any other authority with respect to or covered by wages, salaries or other compensation paid or payable to persons employed by the contractor.
