6. Random testing of material on receipt at GGSSTP store, irrespective of the fact whether or not it was inspected before dispatch, can be carried out by PSPCL. In case of any failure the entire lot shall be rejected at the risk and cost of the supplier.
7. The offer should be kept valid for 120 days.
8. The supply /delivery of material must be within 60 days from date of issue of Purchase Order.
9. Competent authority may distribute the qty. to more than one firm.
10. Any firm offering discount on quoted price after opening the tenders will be out rightly rejected.
11. The Drawing is tentative for quoting rates. The firm should see the sample at GGSSTP site for proper material and dimensions. The firm shall give guarantee for fitment of material procured in mother equipment.
12. All other general terms and conditions as per Annexure-B attached.
13. Quotation of only those firms should be considered who are themselves manufacturer of crusher spares and has delivered material of Secondary crusher of 750 to 1000 TPH capacity in the past to GGSSTP, GNDTP, GHTP and NTPC only.
14. Test Reports only from NABL Accredited lab are acceptable at the time of inspection at firm premises. If defects develop in the material on testing on-load after installation, the firm will resupply the complete material free of cost with the test reports of NABL accredited lab.
