#### Terms & Conditions:-

1. The tender document shall be opened only to those who have enlisted with PSTCL, PSPCL, erstwhile PSEB, Punjab PWD/ B&R, MES, Railways.
2. All tenders must be accompanied by earnest money at the rates of 2% of the tendered value rounded off to a multiple of Rs. 10/- on the higher side subject to minimum of Rs 5000.00 and maximum of Rs 10.00 lacs except in the case of those tenders who have specially exempted there under. DD should be in the favour of **Resident Engineer Shanan Power House, PSPCL, Joginder Nagar HP.**
3. All the tender must be accompanied by Tender Fees of Rs 1180/- in form of BA-16 or DD in the favour of **Resident Engineer Shanan Power House, PSPCL, Joginder Nagar HP.**
4. Original DD of tender fee and earnest money will be submitted by contractor in the office of Sr.Xen/Civil,Shanan Power House, PSPCL, Joginder Nagar before date and time of opening the tender if Original DD of tender fee and earnest money will not submitted, tender will be rejected by competent authority without any notice. Earnest money shall be submitted in separate envelope.
5. All tenders must be accompanied by Similar works performance certificates like Gate works/Hydraulics works/Similar works of mechanical nature during last 07 years ending last day of month previous to the one in which applications are invited should either of the following:-
  - a. Three similar completed works costing not less than the amount equal to 1.52 Lacs each.
  - or
  - b. Two similar completed works costing not less than the amount equal to 1.9 Lacs each.
  - or
  - c. One similar completed work costing not less than the amount equal to 3.05 lacs.
6. Warranty period of the workmanship will be 12 months from the date of successful completion of work.
7. Within the warranty period on defect /poor workmanship the firm/ contractor must be bound for respond and to take corrective action immediately within 5-7 days or as informed by Engineer-in-charge
8. Conditional and incomplete tenders will not be accepted.
9. The tender shall be accepted to those tenderers who have GST No, Pan No.
10. Contractor will ensure the original specifications of the material i.e. pulley bearing, rollers, rollers pins, bushes of roller & hoisting sling as work is of critical nature.
11. The competent authority reserves the rights to reject any or all tenders without assigning any reasons.
12. In case the date of opening of tenders happens to be a holiday the tender will be opened on the next working day at the same time
13. The work shall be completed within two (02) months from the date of issue of work order or as per the requirement of the department. However any extension in completion period shall be granted as per site requirements if required. The time allowed for carrying out the work as entered in the contract shall be strictly observed by the contractor and shall be reckoned from the date on which order to commence work is given to the contractor. The work shall throughout the stipulated period of the contract be proceeded with all due diligence (time being deemed to be the essence of the contract on the part of the contractor) and the contractor shall pay as penalty an amount equal to one half percent of the estimated cost of the whole work




as shown in the contract for every week, the work remains unfinished after the contract completion period, provided always that the entire amount of compensation to be paid under the provisions of this clause shall not exceed 10 percent of the estimated or actual cost of work whichever is higher.

14. All T&P/Machinery/Labour related to work are to be arranged by the firm.
15. All statutory deductions shall be made from the bill. GST will be paid extra as per GST Act. Contractor will supply the attested photo copy of registration certificate & proof of payment against this work (Penalty for delayed payment will be to the contractors account). Contractors component of GST shall be paid only after furnishing of following certificates:-
  - i) Certified that transaction on which GST is claimed has been/ will be included in the return submitted/to be submitted under GST law and the amount claimed from the PSPCL has been/shall be deposited with GST Authorities.
  - ii) Certified that the supply on which GST has been charged have not been exempted under the GST act or rules made there under and GST charged on these supplies is not more than what is payable under the provision of relevant Act.
  - iii) Certified that we shall indemnify the PSPCL in case it is found at a later stage that wrong or incorrect payment has been received on account of GST, the same will be refunded.
  - iv) Certified that we are registered dealer under GST Act and our registration no. is \_\_\_\_\_.
  - v) Further any loss due to non-availability of ITC or levy of penalty/interest payable by PSPCL on account of non-filing of return or non-compliance or any misstatement given under the provision of GST act by the contractor shall be recoverable from them.
11. Overall lowest bidder will be considered as L-1 and negotiations if required shall be held with the lowest (L-1) tenderer only.
12. Work Regulation 1997 with amendments from time to time will also be applicable, the copy of the same can be downloaded from PSPCL website.
13. Before any running payment is allowed against the work the contractor shall be required to sign the contract agreement. He will affix non-judicial stamp papers worth Rs.25/- on the face of the agreement as required under the Indian stamp act.
14. Any penalty imposed on factory manager/occupier by the competent court due to violation of any provision shall be recovered from contractor.
15. Income tax will be deducted at source as per income tax act, 1961 & contractor will intimate his Pan No & supply the attested copy of his PAN card while submitting his tender/quotation. Income tax shall be deducted from each running bill.
16. All safety appliances required for the workers shall be provided by the contractor and PSPCL shall not be responsible for any accident involving the workman during the course of carrying out jobs due to lack of safety appliances or the negligence of workers. Contractor will nominate Safety Officer/Stewards who will visit the site on daily basis to implement safety and maintain proper record thereof.
17. The different quantities against each item of work, given in the schedule of quantities can vary up to any extent till/for the completion of the work. However the quantities of work actually executed shall be measured/recorded in SMB & shall be paid at the allotted rate.
18. The person whose tender shall be accepted (hereinafter called the contractor) shall permit owner/Engineer at the time of making any payment to him for work done under the contract to deduct such sum as will (with the earnest money deposited by him) amount to 5% (five percent) of gross value of work done. Such deductions are to be held by owner/Engineer-in-charge by way of Security Deposit. All compensation or other sums of money payable by Contractor to the owner/Engineer under the terms of this contract may be deducted from or paid by the sale of sufficient part of security deposit or from any sums which may be due



or may become due to the contractor by owner/Engineer on any account whatsoever and in the event of his security deposit being reduced by reasons of any such deduction or sale aforesaid, the contractor shall within 10 days thereafter make good in cash any sum or sums which may have been deducted from or raised by sale of his security deposit or any part thereof. The security deposit shall be refunded to the contractor after the expiry of defects liability period, which is six months from the date of issue of completion certificate or payment of final bill whichever is later. No. Interest shall be payable to the contractor on the amount of security deposit. The security deposit is to be deducted on the gross amount of all running bill and final bill. The earnest money deposited at the time of tender will be treated as part of the security deposit.

19. If the contractor refuses or neglects to execute the work, the work will be got done on his risk and cost & his earnest money will be forfeited.
20. The work should be as per PWD specification and the satisfaction of the Engineer in charge.
21. The Contractor shall submit the annexure A & B dully filled and signed with all respect at the time of submission of his bid.
22. Any dispute regarding this work will be settled in the Joginder Nagar.
23. GST TDS @2 % on Net payment will be deducted as per rules.
24. Labour Cess @1% on Net payment will be deducted as per rules.
25. Telegraphic quotations will not be accepted.
26. The rate quoted will remain valid for acceptance for 120 days from the date of opening.
27. Contractor shall abide all labour laws amended from time to time.
28. After the work is completed, final bill would be paid on the certification of an officer not below the rank of Sr. Executive Engineer that the work is done according to drawings and specifications attached to the tender, if any additions and alterations have been carried out, detailed measurements in respect thereof shall be recorded and extra payments or deduction are to be regulated as per item rates quoted by the contractor while submitting the tender and if there are any items in the additions and alteration for which the contractor has not quoted a rate, the payment shall be regulated as per clause for "extra items".
29. The contractor shall be responsible for all shall pay any compensation to his workmen payable under the workmen's Compensation Act, 1923 (VIII-of 1923) herein after called the said Act for injuries caused to the workmen, if such compensation is paid by the PSPCL as principal under sub section (i) of section 12 of the said Act on behalf of the contractor, it shall be recoverable by the PSPCL from the contractor under sub section (2) of the said section. The contractor shall pay such amount of the compensation of demand failing which it will be recoverable from him by deducting it from sums that may be due or become due to the contractor by the PSPCL under the contractor or otherwise.
