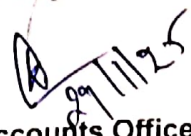

The Cost Accountant shall certify the Allocation Statements for segregating the cost of generation business and distribution business and further segregating the cost of wheeling business and retail supply business of PSPCL for the FY 2024-25.

7. The work of Maintenance of Cost Accounting Record for year should be completed within time period specified by Central Government norms.
8. If any delay is made in submission of Cost Accounting Records by the Cost Accountant or the Firm of Cost Accountants, he/she shall be penalised as per the provisions of Work Regulations 1997 of PSPCL and Companies Act 2013.
9. The Tenderers shall submit his/her personal profile along with tender/ quotation on prescribed tender form attached therewith and if found un-satisfactory his/her tender documents so received shall be re-sealed and placed in the record.
10. Cost of tender specification and EMD shall not be accepted through cheque.
11. Lump sum payment shall be released after submission of certified copy of Cost Accounting Records in the form CRA-1.
12. All the statutory deduction shall be done at the time of release of payments.
