- 2) Completion period: From the date of allotment order up to 29.02.2024.
- 3) The detailed set of NIT specifications will be available in the office of Addl.SE/Civil Mtc. Cell-I, PSPCL, Patiala on payment of Rs. 590/- (inc. GST), non refundable for each set in cash or through crossed demand draft in favour of Addl.SE/Civil Mtc.Cell-I, PSPCL, Patiala.
- 4) Tenders of such bidder who do not purchase the set of NIT specifications shall not be opened.
- 5) Earnest money only in the form of PSPCL cash receipt or crossed demand draft in favors of Addl.SE/Civil Mtc.Cell-I, PSPCL, Patiala, of any scheduled bank (except Canara Bank and Yes Bank) payable at Patiala must accompany the tenders in separate envelope.
- 6) Tenders without earnest money shall not be opened.
- 7) Tender documents shall be issued only to those tenderers who prima facie met the qualifying requirements. However issue of tender documents shall not automatically construe qualification of the tenders for allotment of work, which shall again be determined during bid
- 8) PSPCL reserves the right to reject/accept any or all the bids received at its discretion without assigning any reason what so ever.
- Tenders shall be valid for acceptance up to 120 days from the date of their opening.
- 10) Tenders received telegraphically/ through fax/ through telex/ through email/ through telephone or incomplete tenders shall not be accepted.
