A set of tender documents containing technical specifications, general instructions, terms & conditions can be obtained on any working day during office Hours up to date & time mentioned above on payment of amount as mentioned above for non-refundable tender cost per set by cash or by demand draft in favour of PSPCL or Senior Executive Engineer Civil Construction & Maintenance Division, PSPCL, Ludhiana.
- 2. The tender documents will be issued preferably to those Co-operative Labour & Const. Societies who are registered with Registrar / Assistant Registrar Co-op. Societies as given in the Schedule "A" above.
- 3. The Societies / Contractors should have registered EPF Number, Pan Number, GST Number and they will produce documentary proof thereof.
- 4. The Societies / Contractors will quote their % above /below or at Par with respect to departmental rates on the prescribed price bid prepared by this office. The percentage quoted by the contractor should be exclusive of GST.
- 5. The competent authority reserves the right to reject any or all the tenders received

- without assigning any reason what so ever.
- 6. Conditional tenders and tenders received telegraphically / Fax / Telex and tenders which are not on the prescribed form issued by this office shall not be accepted.
- 7. If due date of opening of the tender happened to be the holiday, the tender will be opened on next working day at the same time.
- 8. Terms & conditions given in the schedule C (Section I to IV) of PSEB Work regulations 1997 with latest amendments shall be strictly adhered by the contractor.
