- 4. The Societies / Contractors will quote their % above /below or at Par with respect to departmental rates on the prescribed price bid prepared by this office. The

percentage quoted by the contractor should be exclusive of GST.

The competent authority reserves the right to reject any or all the tenders received without assigning any reason what so ever. 5.

- Conditional tenders and tenders received telegraphically / Fax / Telex and tenders which are not on the prescribed form issued by this office shall not be accepted. 6.
- If due date of opening of the tender happened to be the holiday, the tender will be 7. opened on next working day at the same time.
