10. All statutory deductions shall be made from the bill. GST will be paid extra as per GST Act. - Income tax will be deducted at source as per income tax act, 1961 & contractor willintimate his Pan No & Supply the attested copy of his PAN card while submitting histender/quotation. Income tax shall be deducted from each 15.
- All safety appliances required for the workers shall be provided by the contractor and PSPCL shall not be responsible for any accident involving the 16. appliances or the negligence of workers Contractor will nominate Safety Officer/Stewards who will visit the site on daily basis to implement safety and
- The different quantities against each item of work, given in the schedule of quantities can vary up to any extent till/for the completion of the work. However the quantities of work actual executedshall be measured/ recorded in 17. SMB & shall be paid at the allotted rate.
- Security @5% will be deducted from the running/Final bills.
- If the contractor refuses or neglects to execute the work, the work will be got 18. done on his risk andcost & his earnest money will be forfeited. 19.
- The work should be as per PWD specification and the satisfaction of the 20.
- The Contractor shall submit the annexure A & B dully filled and signed with all respect at thetime of submission of his bid. 21.
- Any dispute regarding this work will be settled in the Joginder Nagar.

- Contractor shall abide all labour laws amended from time to time.
