- 4. The Societies / Contractors will quote their % above /below or at Par with respect to departmental rates on the prescribed price bid prepared by this office. The percentage quoted by the contractor should be exclusive of GST.

- Conditional tenders and tenders received telegraphically / Fax / Telex and tenders 6. which are not on the prescribed form issued by this office shall not be accepted.
