If bids are not submitted in this manner or Documents/EMD in Part 1 is incomplete as per Eligibility criteria, Price bid will not be opened and the tender bid will be rejected.
- 3. Earnest Money should be deposited along with tenders as per tender notice. Tender without Tender Cost and EMD (if applicable) shall not be accepted. In case of tender not accepted, the Earnest Money shall be refundable within 30 days of the award of Order/Contract to the successful tenderer.

- 24. If the work not completed within stipulated period, the penalty @ 0.50% per week for the delay of the cost of work subject to maximum 10 % of Estimated Total Cost of the work shall be recovered from as per clause no 3.14 of work regulation 1997 amendment from time to time.
- 25. The contractor shall execute the contract agreement in non-judicial stamp paper worth Rs.50/- (Rs. Fifty) within 7 days after issue of allotment letter/work order.
