 - a) Three similar completed works costing not less than the amount equal to 40% of the estimated cost each (4.48 Lacs)
OR
 - b) Two similar completed works costing not less than the amount equal to 50% of the estimated cost each (5.61 Lacs).
OR
 - c) One similar completed work costing not less than the amount equal to 80% of the estimated cost (8.97 Lacs).

Similar nature of work means construction/repair/renovation of buildings/ roads/ yard foundations etc.

3. The bidder should have EPF registration number and ESI registration no. from the concerned authority.
4. The bidder shall have Bank Solvency of at least Rs. 3.36 lacs issued in period not more than one year from the last day of month previous to the one in which applications are invited.
5. Average annual financial turnover duly audited by CA during the last three years ending 31st March of previous financial year should be at **least Rs 3.36** lacs.
