Division, PSPCL, Ludhiana payable at Ludhiana. Balance amount shall have to be deposited within 10 days.
- 3. The taxes as per Punjab General Sales Tax/GST/TCS shall be applicable.

- 5. Debris will be sold on "As is and where is" basis. The arrangement for lifting of debris will be made by the bidders himself. The bidders can see the site before taking part in the auction.

- 9. In case the quarters get damaged due to fire or any other cause, the department shall not be responsible for the same.
- 10. The permit/contract shall remain in operation up to one month.
- 11. No damage to any other structure of PSPCL shall be done by the bidder in
