

Criteria


1. **Registration:-**

- The bidder/ Contractor should be registered / enlisted for the execution of civil works with PSPCL, PSTCL, PWD, Railway, MES, NTPC, Central Govt. or other such organizations for civil works
- Contractors/firms desirous to take part in the tenders can also get themselves registered with Civil Mtc Circle by sending their application to the office of ASE/PCM-2., at least 15 days prior to the last date of submission of tender, along with DD of ₹1180/- (inclusive of GST) in favour of AO / O&M, GGSSTP, Ropar along with the requisite documents as

mentioned below from sr. no. 2 to 7.

2. Proof of having EPF A/c No
3. **EPF clearance certificate**:-EPF clearance certificate for last financial year needs to be obtained. In the event of non-availability of clearance certificate proof of deposit of EPF for last two years shall be attached.
4. **ESI code** ;Proof of having ESI code
5. Proof of having **GST registration No.**
6. Proof of having **PAN Card**
7. **Affidavit**: An affidavit in original , Duly attested by Executive Magistrate /Notary public to affect that :
  - a) The firm is not a defaulter in respect of deposition of EPF/ESI to concerned EPF/ESI department for the workers deployed against work order placed by PSPCL or any other organization on it during last five years. In any case, the responsibility for deposition of EPF/ESI of workers engaged by the firm shall rest with the firm only. In case, the firm is found defaulter at any stage in this regard, the contract shall be cancelled without any notice.
  - b) That the firm has not been black listed by any government/public sector undertaking during the last 5 years.

**Note**-If any fresh Pb.Govt notification is issued by Registrar Co-operative Societies Punjab regarding any preference/relaxtion to Co-op Societies for participation in tenders,till the last date of submission of tender,the same shall be applicable for this tender also.

## SECTION-E

### SCOPE OF WORK AND WORKING CONDITIONS:-

1. The job includes laying the concrete foundation with RCC M 30 Grade concrete for In-motion weigh bridge and M20 RCC Grade Concrete for Wet Ash Handling House Stage-II
2. The work is to be completed in 60 days from the date issue of work order of Lol whichever is earlier.
3. Any other items not covered in the scope of work shall be paid at CSR+ quoted premium or by framing analysis of rates as per standard norms.
4. The quantum of work can be increased or decreased upto any extent, subject to condition that total cost of work does not exceed by 35%.
5. Water charges, if supplied will be recovered @ Rs. 1.50 per Rs. 1000/- of the total amount of work done.
6. The Officer In-Charge may at any time cancel this work order issued to the contractor/ Societies.
7. The material, T&P etc. will be arranged by the contractor at his own cost. However cement shall be supplied by the department free of cost so the bidder shall quote his rate excluding the cost of cement.
8. Penalty: If contractor fails to execute the work within stipulated completion period, penalty @ 1/2 % per week or part there of subject to maximum 10% of the total cost of work will be recovered from the contractor.
9. If the contractor fails to start the work within a week of allotment against his quoted rates, his earnest money will be forfeited and he will be debarred from submission of other quotations for one year.
10. Payment shall be made by A.O/O&M, GGSSTP, Rupnagar as per work regulations of PSPCL.
11. Income tax if applicable shall be deducted as per rules.
12. The sale Tax/VAT, if applicable shall be deducted as per rules.
13. GST : GST will be paid extra after production of deposit of same by the contractor.
14. **Age limit for workmen** to be employed by contractor shall be 18 to 60 years.
15. Security will be deducted from each running bill @ 5% of the cost of work executed in each running bill of the contractor. The earnest money deposited by the contractor will be converted into the security deposit. The security deposited will be released after 6 months from the date completion of finalization of accounts, whichever is later.
16. The bidder shall have to get the material approved from the Engineer-in-charge before start of work.
17. The work shall be got executed as per specification of the work order/PWD specification.
18. **EPF:** The contractor shall abide by all the statutory rules regarding provident fund as per EPF Act- 1952 as amended to date and issue a monthly statement of deposited EPF to this office with a certificate that statement furnished is true and correct and no eligible employee/ worker has been excluded from the list. The bidder shall submit permanent EPF number while requesting for tender documents. The

contractor shall be liable to discharge all other statutory obligations that may be applicable in his case including provident fund to his workers. The contractor shall submit a statement of EPF amount due to be deposited with EPF authorities (Employee & Employers share including inspection/ administration charges) with each running bill for issuing a separate cheque to EPF authorities. The cheque issued in the name of EPF authorities shall be deposited by the contractor himself along with 3A & 6A forms etc. and submit the proof of having deposit the same with the next running bill. The above mentioned shares (both of the employee and contractor) may vary as per rules and regulations from time to time and the contractor is to follow the rules strictly.

19. ESI : The contractor shall obtain independent ESI code and shall discharge his liabilities. The contractor shall furnish the statement with each running bill of ESI amount due to be deposited by the contractor (Employee & Employer's share etc) for issuing a separate cheque to ESI authorities. The cheque issued in the name of ESI authorities shall be deposited by the contractor himself and shall submit the attested copies of documentary proof of giving deposited the same with the next running bill.


20. In addition to above conditions Section- I,II,III & IV of Work Regulations 1997 of PSEB ( now PSPCL), amended time to time, shall be binding.


21. SINGING OF CONTRACT: In the event of tender being accepted an intimation shall be given to the contractor who shall there upon attend office of Accepting Officer to sign copies of the specifications and other documents and to execute the contract agreement (on Non Judicial Stamp Paper worth Rs. 25/-) within 15 days of the intimation of the acceptance of the tender him failing which acceptance of his tender shall be cancelled and his earnest money will be forfeited.

22. **PAYMENT OF TERMINAL/SERVICE BENEFITS:**

The contractor/firm must have to pay all the applicable terminal/service benefits (i.e. Bonus, Gratuity/retrenchment compensation, leave encashment etc.) for the contract period to all the workers within 45 days after completion of contract period including extended period, if any. Delay in payments will attract penalty. All the payments to the workers shall be made through Cheque /Bank only.

Penalty @ Rs. 500/- per day in case of workers strength is up to 50 nos. or Rs. 1000 per day for workers strength above 50 nos. shall be levied for delay in payment to terminal benefits etc. if not made in stipulated period. In case of non-payment of all terminal /service benefits to workers within stipulated period it will be treated as non-compliance of terms and conditions of contract and PSPCL may consider cancelling firm's registration for the work/works
