, I am directed to invite reference to circular letter No. 10(2)-7 HBIV-83/27007 dated the 25th October, 1983 issued by the Department of Health and Family Welfare, Punjab, vide which the scheme of incentives for the State Government employees for promoting small family norms was introduced. The said circular inter-alia provides that the special increment in the form of Personal Pay not to be absorbed in future increases in pay either in the same post or on promotion to higher post, granted as a concession for adopting the terminal method of family planning, shall be at the rate of the next increment due at the time of grant of the concession and will remain fixed during the

In pursuance of the recommendations of Third Punjab Pay Commission, the Punjab Civil Services (revised pay) rules, 1988 have since been notified, under which the pay fixation etc. in the revised scales effective from 1.1.86 is required to be done. A clarification has been sought as to how the aforesaid 'personal pay' is to be treated while allowing pay in the revised scales. matter has been considered and it is hereby clarified that in the case of the employees who got the said special increment on a date earlier to the 'appointed day' (as defined in rule 3 of the Punjab Civil Services (Revised Pay) rules, 1988), the amount already allowed in the pre-revised scale shall remain unchanged even after coming over to the revised pay scale under the said rules. However, in the case of those employees who got the said increment on or after the said 'appointed day', the rate of increment shall be at the rate of increment as available in the revised pay scale.

In addition, one fare of the class entitled shall be allowed to the employee himself on his transfer when his family does not accompany him in the first instance.

- 2.- The instructions/orders issued from time to time on the subject shall be treated to have been modified to the extent of the decisions contained in this order.
- 3.- The decisions contained in this order shall be applicable with reference to the pay scales revised vide Punjab State Electricity Board (Revised Pay) Regulations, 1988, and shall be effective from 1-12-1988. 10 2010 mill shard
