Subject: Grant of fresh opportunity to exercise option for coming over to the pay scales revised w.e.f. 1.1.96.

PSEB vide office order No. 341/ERC dated 30.4.98 revised the pay scales (conversion scales) of its regular employees w.e.f. 1.1.96 introducing "PSEB (Revised Pay) Regulations-1998" which contained necessary provisions to exercise option for coming over to the revised scales within a period of three months of the date of circulation of these Regulations. Subsequently, categorywise pay scales were also notified vide O/O No. 389/Fin. dated 13.6.2000 and O/O No. 399/Fin. dated 30.11.2000.

2. As per provisions of Reg.-6 of (Revised Pay) Regulations *ibid*, where a pay scale is further revised by any subsequent order, another option can be exercised by the employee concerned within a period of three months of the date of issue of such order.

3. There has been a demand from various unions/associations that most of the employees were not aware ~~of~~ regarding provisions of (Revised Pay) Regulations, 1998, that is why they could not avail the opportunity to exercise fresh option. According to them, many of the employees are put in disadvantageous position in the matter of re-fixation of pay in the revised pay scales.

4. Although, ignorance of rules/executive instructions is no excuse to entertain such requests after expiry of given limitation period, yet as a gesture of good-will, it has been decided to allow a fresh opportunity to the effected employees to re-exercise the option for re-fixation of pay in the revised scales, latest by 31st March, 2001.

Subject: Works expenditure - Disposal of estimates.

Instructions regarding disposal of estimates were circulated vide this office Memo No. 100187, 180232/1/40/Fin-83-84 dated 14-9-87. According to these instructions, the proposal seeking administrative approval/technical sanction of the Board in respect of the works estimates, was required to be sent to Secretary (Board Section) for proper scrutiny and examination. The Board Section after taking necessary action in the matter used to pass on the estimate(s) to the Finance Section for advice/concurrence after obtaining administrative approval of the Member, Incharge.

2.- The matter regarding seeking administrative approval/Technical sanction in respect of works estimates has been reconsidered. In order to speed up the work of disposal of these estimates, it has been decided to modify the existing procedure to the extent that the works estimates may be sent to Finance section by the Chief Engineers concerned after obtaining the approval of member/incharge at their own level. While submitting these estimates to the Finance Section, it should invariably be mentioned in the forwarding letter by the CE's that the estimate(s) in question has/have been approved by the concerned member Incharge. Further, a photo copy of duly collected in respect of such approval, may also be attached and sent to Finance Section with the forwarding letter.


