Subject: Amendment to PSEB Provident Fund Regulation, 1960 crediting of arrears of revision of pay scales into G.P. Fund.

Under the existing rules, a subscriber has a right to fix his amount of monthly subscription to his G.P. Fund account at the beginning of the financial year and cannot change it during the course of that year.

2.- On the receipt of representations from a number of officers regarding depositing their entire amount of arrear which became due to them on account of revision of scales with effect from 1-1-1986 into G.P. Fund account, the matter has been considered and it has been decided that besides the regular monthly subscription fixed under sub regulation (1) under Regulation 13 of G.P. Fund Regulations, 1960, a subscriber shall have the option to subscribe to his G.P. Fund account during the year 1989-90 the whole or any part of the arrears, which became due to him on account of ^{of} revision of pay scales w.e.f. 1-1-1986.
