
- i) The 'Hardship Allowance' will not be treated as pay.

The Punjab State Electricity Board is pleased to make the following Regulations, namely :-

1. Short title and commencement.- (1) These regulations may be called the Punjab State Elec. Board (Treatment of Dearness Allowance and Adhoc Dearness Allowance as Dearness Pay) Regulations, 1988.
(2) They shall come into force on and w.e.f. the first day of April, 1988.
2. Application.- (1) Save as otherwise provided by or under these regulations, these regulations shall apply to the persons who have been appointed to the services and posts in connection with the affairs of the PSEB and to the work-charged employees of the PSEB.
(2) These regulations shall not apply to the:-
 - a) Members of the All India Services serving in connection with the affairs of the Punjab State Elec. Board ;
 - b) Persons not in the whole time employment of the P.S.E.B. ;
 - c) Persons paid out of contingencies ;
 - d) Employees whose scales of pay have been determined on the recommendations of the University Grants Commission ;
 - e) Persons employed on contract basis, except when the contract provides otherwise; and
 - f) Persons specifically excluded wholly or in part from the operation of these regulations.
3. Definitions.- In these regulations, unless there is anything repugnant in the subject or context 'appointed day' means the first day of April, 1988 and from which day effect is to be given to these regulations:

Provided that in the case of a Board employee appointed after the first day of April, 1988 'appointed day' shall mean the day on which he joined or joins the post.

4. Treatment of Dearness Allowance and Adhoc Dearness Allowance as Dearness Pay.- with effect from the appointed day, the Dearness Allowance and the Adhoc Dearness Allowance admissible from time to time up to consumer price index 608 in terms of the order in force in this behalf from the first day of January, 1986, to the employees of the PSEB to whom these regulations apply, shall be treated as Dearness Pay for the following purposes, namely :-
- i) grant of house rent allowance ;
 - ii) grant of compensatory allowance ;
 - iii) grant of travelling allowance and daily allowance ;
 - iv) grant of project allowance ;
 - v) grant of non -practising allowance ;
 - vi) retirement benefits allowed in accordance with the provisions of the Punjab Civil Services Rules Vol.II read with the orders, if any, issued in this behalf from time to time by the Punjab Govt./ Punjab State Electricity Board.
 - vii) encashment of leave at the time of retirement in terms of the provisions of regulation 8.22 of the P.S.E.B., MSR, Vol-I, Part-I.
 - viii) recovery of rent from the employees of the PSEB occupying PSEB allotted accommodation ;
 - ix) subscriptions to the general provident fund or the contributory provident fund ;
 - x) grant of deputation allowance and determination of leave salary and pension contribution; and
 - xi) determination of quantum as well as limits of admissibility of various loans and advances referred to in regulation 10.13 of the Punjab Financial Rules, Volume-I.
5. Option.- The employees of the PSEB serving on or immediately before the appointed day to whom these regulations apply shall have the option to get or not to get Dearness Allowance and Adhoc Dearness Allowance treated as Dearness Pay in accordance with the provisions of regulation 4;

Provided that such an option shall be exercised in the Form appended to these regulations on or before the 30th June, 1988 and the option once exercised shall be final.

Provided further that if any employee fails to give his option by the aforesaid date, he shall be deemed to have opted to get Dearness Allowance and Adhoc Dearness Allowance treated as Dearness Pay in accordance with the provisions of Reg. 4 of these regulations.

6. Interpretation:- If any question arises as to the interpretation of these regulations, the PSEB in Finance Section shall decide it.





Subject: Commencement of works in absence of sanction of detailed estimates.

-:00:-

The provisions of paragraphs 2.89 and 2.90 of PWD Code and Instruction No.50 of M.O.I., interalia, lay down that no work should be commenced nor should any other liability; such as ordering and collection of materials, be incurred in respect thereof, unless the following formalities are completed :-

- i) Its administrative approval has been accorded by the competent authority.
- ii) Its design has been approved and detailed estimate sanctioned.
- iii) Funds allotted.

And, in case of real urgency, the authority competent to sanction the estimate for the work proposed to be taken in hand, may authorise the commencement of work in anticipation of sanction of estimate, in writing. The Divisional Offices concerned should also take immediate steps to get the estimates sanctioned for such works without any delay i.e. at the most within one/two months, when the estimate is to be sanctioned by the S.E./C.E.


2.- Attention is invited to the circular instructions contained in this office Memo.No. 163801/4681/1/40/FB-83-84, dated 31.12.1983, wherein it was requested that the above codal instructions should be followed in letter and spirit by all concerned. It was further made clear that non-observance of these instructions might attract disciplinary action against delinquents.

3.- While considering a case of violation of these instructions, the Board, in its meeting held on 02.12.1987, observed that the practice of starting the works without

getting necessary estimate sanctioned or even obtaining the anticipatory sanction from the competent authority in contravention of para-2.89 and 2.90 of PWD Code, 2nd Edition, deserved to be checked very strongly. It was, therefore, decided to issue suitable instructions so that any violation of the provision ibid thereafter is seriously viewed and defaulting officials dealt very firmly in future.

4.- I am accordingly desired to stress that the above instructions should be followed meticulously in future. It may clearly be understood that any violation of the codal instructions ibid would be seriously viewed by the Board and the defaulting officers would render themselves liable for stern disciplinary action.

The Punjab State Electricity Board is pleased to make the following Regulations further to amend the Punjab State Electricity Board (Revised Scales of Pay) Regulations, 1980, namely :-

1. These regulations may be called the P.S.E.B. (Revised Scales of Pay) (Second Amendment) Regulations, 1988.
2. In the said regulations, in regulation-5, after clause(iii) of proviso to sub-regulation (1), the following clause shall be inserted, namely:-

"(iv) a Board employee holding any post mentioned in the revised pay structure, before the date of notifying the revised scales of pay (21st Feb., 1980), who is granted selection grade or enhanced scale of pay on promotion retrospectively but after the 21st Jan., 1982, from any date falling within the 1st day of Jan., 1978 to the 31st day of March, 1981, notwithstanding anything contained in this regulation and notwithstanding any option already exercised in this behalf may exercise an option to elect the revised scale of pay from any date later than 1st Jan., 1978, but not later than the 31st March/ within a period of four months from the date of commencement of the P.S.E.B. (Revised Scales of Pay) (Second Amendment) Regulations, 1988, subject to the condition that the Board employee exercising option as aforesaid shall refund the difference between the pay and allowances drawn at the revised rates upto the date of opting the selection grade or enhanced scale of pay on promotion and those drawn at the unrevised rates, if overpaid."




