Subject:- Recommendations of the Fourth Punjab Pay Commission Grant of Dearness Allowance to the Government employees with effect from 1.7.1996, 1.1.1997 and 1.7.1997.

\*\*\*

Sir,

I am directed to say that consequent upon the acceptance of recommendations of the Fourth Punjab Pay Commission with regard to revision of pay scales from 1.1.1996, the Governor of Punjab is pleased to decide that the Dearness Allowance admissible to the employees of the Government of Punjab shall be payable from the dates mentioned below at the following rates:-

Date from which payable	Rate of Dearness Allowance per mensem
From 1.1.1996	No Dearness Allowance
From 1.7.1996	4% of pay
From 1.1.1997	8% of pay
From 1.7.1997	13% of pay

2.- The payment of Dearness Allowance under these orders from the dates indicated above shall be made after adjusting the instalments of the Dearness Allowance already sanctioned and paid to Punjab Government employees w.e.f. 1.1.1996, 1.7.1996 and 1.1.1997 in terms of letter No. 3/2/94-1FP1/3346, dated 24.4.1996, letter No. 3/2/94-1FP1/9113 dated 8.11.1996 and letter No. 3/2/94-1FP1/4376 dated 15.5.1997.

3.- The admissible Dearness Allowance to all employees shall be paid in cash from 1.1.1998 and arrears of admissible Dearness Allowance upto 31.12.1997 would be paid in two instalments. Fifty per cent of the arrears would be given to the employees with their salaries for January, 1998 and the remaining 50% of the arrears with their salaries in April, 1998. In each case half of the due payment would be paid in cash and the other half of the due payment would be paid in cash and the other half being credited to the General Provident Fund Accounts. The interest on the contribution to be made to the General Provident Fund Accounts of the employees in the month of January, 1998 and

April, 1998, shall accrue from the 1st February, 1998 and 1st May, 1998 respectively.

Ready Reckoner showing the admissible amount of Dearness Allowance from 1.7.1986, 1.1.1997 and 1.7.1997 in terms of these orders is appended (at Appendices I to III).

4.- Where any Government employee was, during the said period, not eligible to subscribe to the Provident Fund, the drawal of arrears of Dearness Allowance shall be deferred till the employee concerned becomes eligible to contribute to Provident Fund and the Provident Fund Account is opened in his/her name. In such a case, as and when the Provident Fund Account is opened and the amount of Dearness Allowance is credited thereto, interest will accrue from the 1st February, 1998 and 1st May, 1998 respectively, as the case may be. The Government employees, who have retired or have closed their General Provident Fund Accounts before the issue of this letter or who might close their accounts by the time the arrears are drawn, shall be paid the arrears of Dearness Allowance in cash.

5.- The term "Pay" for the purpose of calculation of Dearness Allowance, shall be the pay drawn in the revised scales of pay, including stagnation increment(s) and Non-Practising Allowance but shall not include any other type(s) of pay like special pay or personal pay etc. In the case of those employees who opt to retain the pre-revised scales of pay, it will include, in addition to pay in the pre-revised scale, stagnation increment(s) and Additional Pay, if any, Dearness Allowance and Interim Relief appropriate to that admissible under orders in existence on 1.1.1996.

6.- The Dearness Allowance will continue to be a distinct element of remuneration and will not be treated as pay.

7.- The payment on account of Dearness Allowance ~~level~~ involving fractions of 50 paise and above may be rounded off to the next higher rupee and the fractions of less than 50 paise may be ignored.

8.- As regards, the employees of State Government Undertakings, other public, quasi-public bodies and Local Authorities constituted by Acts of Parliament or the State Legislature, working under the control of the State Government, whether they receive financial assistance from the State Government or

not, the Governing Body/Board of Directors of the Institutions are authorised to sanction instalments of Dearness Allowance w.e.f. 1.7.1996, 1.1.97 and 1.7.1997 on the pattern as sanctioned herein for State Government employees subject to the same condition viz. the Dearness Allowance with effect from 1.7.1996, 1.1.1997 and 1.7.1997 may be ~~circulated~~ <sup>calculated and</sup> at the payment of the same shall be made on the pattern adopted by the State Govt. and in the absence of Provident Fund Accounts the arrears may be got invested in the employees names by the purchase of National Saving Certificate, National Saving Scheme or Kisan Vikas Patras or Indira Vikas Patras from the Post Offices in the State of Punjab It will be the responsibility of the Administrative Departments supervising the working of the Corporations/Boards and other Institutions to ensure that the payment of Dearness Allowance is made strictly in accordance with these instructions.

9.- The provisions contained in paras 4,5, and 6 of this Department circular letter No. 3/2/94-1EPI/9118, dated the 8th November, 1996 shall continue to be applicable while regulating Dearness Allowance under these orders.

The Punjab State Elec. Board is pleased to decide the revised classification of Cities in the State for the purpose of grant of City Compensatory Allowance to its employees as under :-

i) Classification of Cities on population criterion

Cities with population of 20 lakhs and above but less than 50 lakhs.

'A'

Cities with population of 10 lakhs and above but less than 20 lakhs.

B-1

Cities with population of 05 lakhs and above but less than 10 lakhs.

B-2

ii) The admissible City Compensatory Allowance shall be as under :-

- v) The other existing terms and conditions regarding grant of City Compensatory Allowance shall continue to be in force.


2. The above decisions shall be effective from the 1st September, 1997.

The payment of revised City Compensatory Allowance will be regulated in the same manner as has been adopted by the Board for payment of arrears of fixation of pay of the employees in the revised scales, as notified in the PSEB (Revised Pay) Regulations, 1998, issued vide office order No. 341/PRC-Fin dated 30.4.98 (Fin. circular No. 9/98).

5. The payment of this allowance for the period from 1.1.96 to 31.8.97 will be regulated at <sup>the</sup> then existing rates on the notional pay in the pre-revised scales and the revision of scales of pay w.e.f. 1.1.96 shall have no effect on the admissible amount of this allowance upto 31.8.1997.

Board is pleased to sanction Fixed Medical Allowance @ Rs. 250/- per month to all of its eligible employees/pensioners including workcharged staff except those covered under the Employees State Insurance Scheme, on a uniform basis w.e.f. 1-5-1998 without any option. There shall be no reimbursement for out-door treatment at all with effect from and after 1-5-1998. It is clarified that in respect of employees/pensioners, who had not earlier opted for 'Fixed Medical Allowance', their bills for reimbursement may be entertained for the medicines purchased before 1st May, 1998. The facility for reimbursement of expenditure on in-door treatment however, shall continue as heretofore.

2.- The existing dispensaries would continue to function for prescriptions only with the minimum skeleton staff and the purchase of medicines shall be restricted to first-aid only.
