The payment of this allowance for the period from ' 5. 1.1.96 to 31.8.97 will be regulated at the then existing rates on the motional pay in the pre-revised scales and the revision of scales of pay w.e.f. 1.1.96 shall have no effect on the admissible amount of this allowande upto 31.8.97. An employee can be permitted by the competent б. authority to reside at a place beyond 25 kms from the headquarters, provided he attends to his duties punctually and without detriment to his efficiency.

Board is further pleased to decide that the rate to be charged from the employees, who have been allotted Board's accommodation, on the emoluments in the revised scales of pay, as admissible under the PSEB (Revised Pay)Regulations, 1998, shall be 5% of the basic pay and NPA wherever applicable or standard rent, whichever is less. The liability of such deduction for the period from 1st January, 1996 to 31st August, 1997, shall continue to be governed by the then existing regulations/instructions on the notional pay in the pre-revised scales and the revision of emoluments from 1.1.96 shall have no effect on the liability of this deduction upto 31.8.97.

Subject: Revision of Pay Scales of Board Employees -Mode of payment of arrears.

According to Regulation-9 of PSEB(Revised Pay) Regulations, 1998, issued vide Finance Circular No.9/98 dated 30.4.1998, fifty percent of the arrears of pay to which Board employees may be entitled on account of revision of pay would be paid to the employees with their salaries for the month of May, 1998 and the remaining fifty percent of the arrears would be paid to them with their salaries in July, 1993, and in each case, half of the due payment on account of such arrears would be paid in cash and the other half shall be credited to the G.P.F.Accounts of the employees on each occasion. Similar procedure is to be adopted for regulating the payment of arrears

accruing from revised rates of Dearness Allowance, City Compensatory Allowance, House Rent Allowance and Rural Area Allowance, notified in Finance Circulars No.10/98, 11/98, 13/93 and 14/93 all dated 30.4.1998.

mode of payment, it has been decided by the Board as under:-

The employees have the option to retain their arrears of revision of pay, H.R.A., D.A., C.C.A., R.A.A. to any extant in their G.P.F.Accounts subject to minimum of 50% of the amount. The employees who opt to retain 75% of more of the amount of the arrears in their G.P.F.Accounts, the amount will be credited in their G.P.F. Accounts in May, 1998 (instead of half in May, 1993 and malf in July, 1998).

The employees who have retired from the service of the Board on or after 1.1.1996 and have their G.P.F.balances with the Board under Regulation-38, have the option to get their arrears credited to their G.P.F.Accounts. Similarly, the employees who are to retire from the Board service upto 30.11.1998 also have the option to retain their arrears in their G.P.F. Accounts.

In the case of Board employees who have not been allotted G.P.F.Accounts Nos., the arrears due to them may be kept in G.P.F. after observing necessary formalities with regard to opening their G.P.F. Accounts.
