In exercise of the powers vesting under Section-79 of the Electricity(Supply) Act, 1948 read with item No.18 of the 1st Schedule appended to PSEB. Regulations of conduct of Business-1980, the Punjab State Electricity Board is pleased to order as under:-

" The condition that " Junior Draftsman/Tracer, already promoted as Draftsman before putting in 12 years service in the lower scale will start in the scale of Rs.1800-3200 at the minimum Rs.1800/- and shall be entitled to get increments in that scale only after they have completed the aforementioned minimum eligibility period of 12 years of service" imposed vide office order No. 223/Fin/PRC-1988 dated 3.10.90 would not be applicable in the case of those Draftsmen who had already been promoted as such prior to 1.1.86."
