

Subject: Placement of JES in the 2nd time bound promotional scale of AE already granted promotional scale of B. 2100/3700- Clarification regarding.



Wide Financial Circular No. 6/2000 circulated vide this office memo No. 32645/683/Fin-II/V-5 dated 9th March, 2000 a clarification was issued on a point of doubt whether such of the JES as are once granted the 2nd time bound promotional scale of B.2100/3700 prescribed for DAE non-qualified officials, can be placed in the 2nd time bound promotional scale of AE viz. B.2200/4250 (without initial start of B.2400/-), meant for qualified hands in their cadre eligible for the post of AE, on their subsequently passing the said examination in view of F.C.No. 13/93 dated 1.3.93. The operative part of these clarificatory instructions reads as under:-

" It is clarified that F.C.No. 13/93 dated 1.3.93 stood superseded with the issuance of policy decision notified through this office order No. 305/Fin/PRC dated 28.2.94 to the extent that there will be no change in respect of JES who have not qualified the DAE prescribed for Engg. Subordinates before the grant of 2nd time bound promotional scale and they will remain in the pre-revised 2nd time bound promotional scale of B.2100/3700 already granted to them on completion of 16 year's service."

2.- The whole issue has been considered denovo and

it has been observed that the clarification issued vide FC No. 15/93 still holds good and was not superseded by Board's O/O No. 305/Fin dt. 28.2.94 as had been earlier interpreted in the instructions issued vide FC No. 6/2000 for review of all such pay fixation cases. In short, it has been decided that the clarificatory instructions contained in F.C.No.15/93 will continue to be followed meaning thereby that a JE eligible for the post of AE under PSEB Service of Engineers(Elect./Civil) Regulations, 1965, who has once been granted the second T.B.S. of Rs. 2100/3700 after 16 years service, be given placement in the scale of AE i.e. B. 2200-4250 (2200-50-2400-60-2700-3000-100-4000-125-4250 without initial start of Rs.2400/-) on his qualifying the DAE afterwards without any benefit of promotional increment(s). Resultantly, the instructions issued vide this office F.C. No. 6/2000 are hereby withdrawn.

Subject: Revised rates of Hotel Accommodation/Tourist bungalows for tour out side Punjab & Chandigarh.

The following measures were adopted by the Board for effecting economy in expenditure during the financial year 2000-2001 vide Fin.Circular No.12/2000 dated 14.6.2000:-

- "1. Chairman and Members/Secretary only shall be permitted for reimbursement of actual expenditure incurred towards normal single room rent in a hotel of a category not above Five-Star.
2. All the HODs/Chief Engineers shall be allowed reimbursement of actual expenditure incurred towards normal single room rent in a hotel of a category not above Four-Star.
3. All other employees of the Board with basic pay more than Rs.10,000/- shall be entitled for reimbursement of actual expenditure incurred towards normal single room rent in a hotel of a category not above Three-Star.
4. In case of air travel, travelling in an executive class be avoided by all the officers."

2.- The matter has been reviewed by the Board and it has been decided to extend these measures to the next financial year i.e. 2001-2002 as well.

All concerned are requested to ensure meticulous compliance of these instructions.



2. The question of giving some more financial relief to the families of government employees who die in harness and the death occurs due to causes attributable to service i.e. for reasons which are directly or substantially connected with the performance of official duties and is clearly relatable to performance of such duties, has been under consideration of the State Government. After careful consideration it has been decided that amount of ex-gratia Grant in such cases shall be equal to 24 times the basic pay of the government employee on the date of his/her death with a minimum limit of Rs.1.00 lac and maximum limit of Rs. 3.00 lacs.

3.- Para 3.4 of the Department of Finance Circular referred to above shall therefore read for stand as under:-

" The Ex-Gratia Grant admissible to dependents of the Government employee dying in harness shall be equal to 24 times the basic pay of the employee on the date of his/her death with a minimum limit of Rs. 1.00 lac and maximum limit of Rs.3.00 lac; if the death of the employee occurs due to causes attributable to service i.e. for reasons which are directly or substantially connected with the performance of official duties and is clearly relatable to performance of such duties."

4.- All other provisions of the above circulars shall remain unchanged.

5.- These orders shall come into force with immediate effect.



I am directed to invite a reference to Punjab Govt. letter No. 1/2/2000-1FPIII/8309 dated 2nd August, 2000, vide which the procedure for revision of family pension and recording entitlement in the pension payment order has been laid down. The Accountant General (A&E) Punjab has pointed out that since one portion of the PPO is with the Treasury Officer/Disbursing Bank and the other with the retiree, it will create difficulties for the pensioners in drawing regular pension; if these have to be called for endorsements at his level. On the advice of the Accountant General, it has been decided, in partial modification of the above instructions, that para-6 thereof shall read as under:-

"6" The revised rate of family pension, as authorised by the Accountant General Punjab in accordance with these instructions shall be noted on both halves of the PPO by the Treasury Officer/Disbursing Bank under proper attestation, quoting particulars of the authority issued by the Accountant General."

2.- The above instructions may please be brought to the notice of all concerned working under their control.
