In continuation to this office order No.133/Fin/PRC-1988 dated 9-12-88 and No.142/Fin/PRC-1988, dated 7-3-89, the Punjab State Electricity Board is pleased to decide that the PSEB employees who had drawn Chandigarh Compensatory Allowance/House Rent Allowance at old rates existing on the 1st January, 1986, on the pre-revised scales of pay, may be granted for the period from the 1st January, 1986 to the 31st August, 1988, House Rent Allowance and Chandigarh Compensatory Allowance at the rates prevailing on 1st January, 1986 and subject to all other conditions then applicable, but with reference to the pay drawn by them in the scale of the post as revised on the recommendations of the PSEB Pay Revision Committee. The pay for this purpose in respect of such PSEB employees will be as defined in regulation 2.45(i) of PSEB, MSR, Vol-I, Part-I. The same benefit will also be admissible to PSEB employees, who continued to draw pay in the pre-revised scales and revised pay in their cases will include in addition to pay in the pre-revised scale, Dearness Pay, Dearness Allowance, Additional Dearness Allowance, Adhoc Dearness Allowance and Interim Relief appropriate to the pay admissible under the orders in existence on the 31st December, 1985.

2.- The maximum ceiling prescribed for the grant of Chandigarh Compensatory Allowance/House Rent Allowance under the old formula existing as on 1-1-1986 would remain unchanged.

3.- Necessary adjustments in regard to payments already made to the Board employees by way of Chandigarh Compensatory Allowance/House Rent Allowance for the period from 1-1-1986 to 31-8-1988 shall be made while granting Chandigarh Compensatory Allowance/House Rent Allowance as per this order.

4.- The decision contained in this order shall not apply for any other allowance viz. Project Allowance, Compensatory Allowance, Travelling Allowance/Daily Allowance etc.

5.- The payment of arrears, for the period from 1-1-1986 to 31-8-1988, on account of Chandigarh Compensatory Allowance/House Rent Allowance may be made immediately to Class-IV employees for the present.

on the pattern of Punjab Govt., is pleased to decide that
the rates of Dearness Allowance payable to the employees
of the Board shall stand modified with effect from 1st January,
1990 as follows :-

Pay range for the employees who are in receipt
of pay in the existing un-revised scales shall be the same.
as defined in paragraph-2 of this office order No.398/Fin-38/
Vol-VI dated 30-3-87. As regards the employees who have
since started drawing pay in the revised scales of pay
under the Punjab State Electricity Board (Revised Pay)
Regulations, 1988, the pay range shall be on the basis of
their pay as defined in Regulation 2.45(i) of PSEB MSR Vol-I,
Part-I, which is commonly known as "basic pay".

2.- The payment on account of dearness allowance
involving fraction of 50 paise or above may be rounded off
to the next higher rupee and the fraction of less than
50 paise may be ignored.

3.- These orders are also applicable to the work-
charged employees.

4.- These orders will not be applicable to the staff paid from contingencies, casual labour, staff employed on daily wages and those working on piece-rate system. These orders will also not be applicable to those employed on contract basis except where dearness allowance is admissible in terms of their contract.

5.- The Ready Reckoners showing the amount of dearness allowance payable in cash from 1st January, 1990 onwards in terms of these orders are enclosed at Annexure-I (applicable to those in receipt of pay in the existing un-revised scales) and Annexure-II (applicable to those in receipt of pay in the revised scales under the PSEB(Revised Pay) Regulations, 1988.
