Punjab State Electricity Board have recently revised the pay scales of its employees w.e.f. 1.1.1996 and also sanctioned House Rent Allowance, City Compensatory Allowance and Rural Area Allowance at the revised rates with effect from 1.9.97.

Some of the field officers have been making inquiries in regard to the specific instructions, if any, for checking of the pay fixation cases and payment of arrears accruing from implementation of revision of pay scales and allowances.

requirement particularly for all those orders involving finances of the Board, it was expected that the instructions already issued vide this office circular No.7/89 dated 31.1.89 during last pay revision for scrutiny of the pay fixation tases will be followed/complied with by all the Sr.Accounts Officers/Accounts Officers concerned. Any how, it is again made clear that release of pay in the revised scales as also payment of arrears of pay fixation and allowances will only be allowed after its pre-audit by the Sr. Accounts officers/Accounts officers as under:-

i) Sr.A.O./A.O. in the pre-audit offices at various projects.

In respect of employees posted at the respective projects, including CE/Civil, Chandigarh and its subordinate offices.

ii) Accounts Officer/P&A (CAO Office)

In respect of employees whose pay is drawn by the Pay & Accounts Section.

In respect of employees posted in the Board's Secretariat, C.E.s, CAOS, CA, C.C./F, Chief/CC&R and DIG/V&S (Now CE/Vigilance whose pay is pre-audited by EAD Section.

iv) Accounts Officers/
(Field)under Chief
Auditor .

In respect of employees posted in Distribution charges within their jurisdiction, CE/North, Jalandhar, CE/Border, ASR, CE/West BTI, CE(Central), Ludhiana . CE/South Frotection Cell and Mtc. Cells and F.L.C. charges etc. situated at various places.

v) Accounts Officer
(Pay fixation party
to be nominated by the
Chief Auditor).

In respect of employees posted under Chief Engineers including their subordinate offices located at Patiala and field.

The audit staff, as mentioned above, shall start checking of the pay fixation cases in the revised scales with immediate effect. It is, therefore, requested that full co-operation may be extended to the audit for this task.
