In continuation of Finance Circular No. 17/88, issued vide this office Memo. No. 77635/665/Fin-49 dated 22.4.1988; it has been decided that the following edditional measures may also be taken for affecting economy inexpenditure during the year 1988-89 :-

i) Grant of Additional perquisites to the employees:

No new allowance or perquisites involving additional expenditure may be allowed to the employees unless the additional expenditure can be met out of profits of the Board.

Control of Inventory:

Holding inventories in excess of current requirements leads to uneconomical blocking of scareefunds, especially when working capital is raised by loans at heavy rates of interest. The inventory should therefore, be kept at the minimum level. For this purpose, detailed scrutiny of all items of inventory may be under-taken and surplus stores be disposed off. The maximum limit of inventory during a financial year should be fixed with reference to actual requirements and this limit should not be exceeded under any circumstances. Maximum limits may please be got approved from the Board.

iii) Capital Expenditure:

A detailed examination may be carried out in respect of various schemes and activities for which provision has been made in the capital budget, in order to assess the extent to which these can be rescheduled or postponed without adversely affecting the functioning of the Board.

Attention is invited to office order No. 127/FRC/ Fin. dated 28.3.1988 vide which an amendment has been made to the PSEB (Revised Scales of Pay) Regulations, 1980. The matter regarding implementation of the provisions contained in the above order has been further considered in the light of instructions contained in Board's circular Memo. No. 178723/ 179028/FP-27 dated 28.10.1980. Vide these instructions, it vas clarified that the ex-gratia increment is to be treated en a part of basic pay. These instructions are to be read alongwith the provisions contained in Rule: 4.14 (2) of Ponjab Civil Services Rules Vol-I/Regulation 4.15 (2) of PSES Main Service Regulations Vol-I.
