Attention is invited to the circular instructions issued vide this office Memo No.177786/179036/VI/213/Vol-III dated 11-9-1987, wherein it was stressed to ensure that J.Es on their transfer or promotion, once they render the material-at-site accounts, are not subjected to unnecessary harassment due to non-checking of their accounts. It was further made clear that their L.P.Cs alongwith service books should invariably be issued within a month positively from the date the account is rendered as per instructions already issued from time to time.

- 2.- Of late, it has been observed that the above instructions are not being complied with meticulously by the concerned field officers which result in avoidable hardship to the concerned officials.
- J.- With a view to obviate unnecessary harasment which the J.Es have to face in the matter of drawal of their salaries due to delay in the issuance of their L.P.Cs, all field Officers are again requested to make it sure that the instructions issued from time to time are followed in letter and spirit and the L.P.C. is sent within a month from the date of issue of account-rendering certificate, positively.
- 4.- It may be brought home to all concerned that non compliance of the above instructions would attract severe disciplinary action against the delinquent officers/officials.
