



Copy of the letter No. 1/29/98-3FFPC/10734 dated 7th Nov. 2000 from Government of Punjab, Department of Finance, (Finance Pension Policy & Coordination Branch) to All Heads of Departments etc. etc.

Subject:- Grant of Dearness Relief to the Pensioners/Family Pensioners of the Government of Punjab-Revised rates effective from 1st July, 2000.

Sir, Madam,

I am directed to invite a reference to this Department Letter No. 1/29/98-1FP3/5457 dated 9th May, 2000 sanctioning the instalment of dearness relief admissible from 1st January, 2000 and to say that the Governor of Punjab is pleased to decide that rate of dearness relief to Pensioners/Family Pensioners/Extraordinary Pensioners etc. of the Govt. of Punjab shall be revised from 38% to 41% with effect from 1st July, 2000 to compensate them for the rise of cost of living beyond average Consumer Price Index 306.33 (as on 1st January, 1996).

1.2 Payment of Dearness Relief involving fraction of a rupee shall be rounded off to the next higher rupee.

1.3 Other provisions governing grant of Dearness Relief to pensioners etc. such as regulation of Dearness Relief during employment/re-employment and regulation of Dearness Relief where more than one pension is drawn etc. will remain unchanged.

1.4 On the analogy of decision taken by Government of India it has been decided to dispense with the issue of ready reckoner alongwith the Dearness Relief orders. It will now be the responsibility of the Pension Disbursing Authority, including the nationalised banks etc. to calculate the quantum of dearness relief payable in each individual case.

Treasury Officers

1.5 All District Treasury Officers/and Public Sector Banks are requested to arrange payment of Dearness Relief pensioners/Family Pensioners etc. on the basis of these orders immediately.

2. The expenditure involved will be debited to the Head '2071-Pension and Other Retirement Benefits.'

3. The liability in respect of pre-1st November, 1966 service of the pensioners and their family pensioners shall be divisible amongst the successor States of the erstwhile State of Punjab i.e. Punjab, Haryana, Himachal Pradesh and Union Territory, Chandigarh in terms of the 14th Schedule of Punjab Reorganisation Act, 1966.



In exercise of the powers conferred by Section 79(c) of the Electricity (Supply) Act, 1948, the Punjab State Electricity Board is pleased to make the following Regulations further to amend the "SEB (Revised Pay) Regulations, 1998" namely :-

1. (i) These Regulations may be called the Punjab State Electricity Board (Revised Pay) Regulations, 1998 (third amendment -2000),
(ii) They shall be deemed to have come into force on and with effect from the First day of January, 1996.
2. In the Punjab State Electricity Board (Revised Pay) Regulations, 1998 the "Second Schedule" annexed thereto as notified vide office order No. 389/Fin-II/6(98)/-S dated 18.6.2000, shall be termed as "Second Schedule", Part-I" and the "Second Schedule, Part-II" is hereby issued as annexed hereto.
3. The arrears accruing from re-fixation of pay in the revised pay scales upto 30.11.2000 will be credited to GPF accounts of the employees in full wherever GPF accounts exist. For the retired employees arrears will be paid in cash as per existing policy in the matter.

regarding revision of family pension of those pensioners who retired
before 1.1.96 and in whose case family pension has not yet become
operational, has been under consideration of the Government. After
careful consideration, it has been decided that as per recommenda-
tions of the IVth Punjab Pay Commission revised rates of family
pension in such cases applicable from 1.1.96 shall be the same as
stated in Punjab Government F.D. letter No. 1/7/98-1FPIII/8709
dated 16.7.98 as under:-

2.- The manner in which family pension and family pension
entitlement shall be revised from 1.1.96 in such cases is detailed

shall be re-fixed as on 1.1.86 on notional basis with
reference to pay actually drawn on the date of retire-
ment, in accordance with the ready reckoner issued by
the Govt. under the Punjab Civil Services (Revised Pay)
Rules, 1988 and again in accordance with the Punjab Civil
Services (Revised Pay) Rules 1998 as on 1.1.96. Family
pension shall then be calculated on the rates mentioned
in para-1 above.
- ii) Those who retired between 1.1.86 and 31.12.95: Pay of
such pensioners shall be re-fixed as on 1.1.96 notionally
with reference to pay actually drawn on the date of
retirement in accordance with the Punjab Civil Services
(Revised Pay) Rules, 1998. The family pension shall be
calculated on the rates mentioned in para-1 above.





Govt. of Punjab, Department of Finance vide its letter No. 7/44/98-FPI/11778 dated 21.10.98 issued clarificatory instructions on some of the provisions of the Punjab Civil Services (Revised Pay) Rules, 1998 with regard to the manner in which pay is to be fixed or increments regulated under certain circumstances. These instructions were circulated

vide this office memo No. 1009/2309/PRC-111 dated 6.1.99 (F.C. No. 1/99) to all concerned for reference/guidance with the directions that the pay fixation already done on provisional basis in the light of guidelines earlier issued by this office vide memo No. 77858/78558/PRC-111 dated 16.6.1998, should be reviewed and recoveries of over-payments made, if any, be effected accordingly.

2. Implementation on some of the issues is still being disputed by the Unions. The matter has been considered and the points of doubt are further clarified as under :-

S. No.	Points	Clarifications
(i)	Whether the benefit under third proviso is to be granted in case of promotion only or on grant of promotional scales also?	As per Punjab Govt. instructions, the benefit under third proviso is to be counted from the stage at which the pay of an employee is fixed on promotion in the existing scale. In PSEB, in addition to regular promotions, there is concept of 9/16 years promotional scales, on grant of which the officer is entitled to the benefits of fixation of pay as admissible on promotion under Reg. 8 of PSEB (Revised Pay) Regulations, 1988. Hence, the benefit under third proviso needs to be counted from the stage at which the pay is fixed on promotion or grant of 9/16 years promotional scales as the case may be.
(ii)	Whether benefit of bunching and stepping up of pay is to be allowed after identifying particular officers/officials in the cadre?	As clarified by Punjab Govt. benefit of bunching and stepping up of the pay in such cases is to be allowed only after identifying the particular officers/officials in the cadre. The implementation of this clarification is not practically possible for the reason that it is not possible to identify various other officers whose pay is getting bunched at the same stage, for each and every official of the Board due to their service record being maintained at different places. Also a small cadres, employee should not be a loser just because there are no other employees actually working at different stages from where pay was

getting bunched. To be fair to one and all, the identification can be made only w.r.t. stages in the scales and not w.r.t. individual employees working at those stages. Consequently, benefit of bunching is to be worked out w.r.t. initial start of pay scale and not w.r.t. the stage at which pay of an individual employee is fixed.

2.- In the interest of affecting economy in expenditure, the board, in its 9/2000 meeting held on 26-9-2000, among others resolved on some of the measures as under :-

- i) No proposal for allowing new incentives, perks, allowances or increase therein involving additional financial implication be entertained. For grant of additional DA, pattern of Punjab Govt. be followed.
- ii) To impose complete ban on purchase of new furniture, display advertisements and office & residential building alterations, furnishing and renovations.
- iii) Local purchase limit for the field offices shall stand reduced to half and field offices will reprioritize their purchases accordingly, quarterly limits to be fixed and observed.
- iv) New projects and expansion projects to be kept on hold for the time being for 6 months.
- v) Purchase of material, equipment & consumable to be kept at the bare minimum only to ensure proper operation and maintenance of system.

- vi) To impose complete ban on creation of new posts, upgradation of posts and filling up of existing vacant posts and posts to fall vacant in future till further orders except by promotion in which case, posts in the feeder cadre are to be kept vacant.
- vii) To divert available manpower from other wings to operation wing to man about 50 posts of SDOs/AEs lying vacant.
- 3.- It may be ensured that above measures are strictly observed and no deviation whatsoever be made during the balance part of the current financial year.




