Copy of the letter No. 16/66/84-3FPPC/4741 dated 14th May, 2001 from Government of Punjab, Department of Finance (Finance Policy & Co-ordination Branch) to All Heads of Departments etc.

Subject:- Grant of Dearness Relief to the re-employed pensioners/ Family Pensioners and Special Family Pensioners.

Sir/Madam,

I am directed to invite a reference to the Finance Department Circular letter letter No. 16/66/84-1FPIII/4294 dated the 14th May, 1997, on the subject cited above, vide which it was clarified that on the basis of decision taken by the Government of India, the employed/re-employed pensioners/family pensioners and special family pensioners, who are already in service, are not entitled to the Dearness Relief on family pension.

2.- The matter has been under adjudication before various courts including the Supreme Court of India. Besides this, the Vth Central Pay Commission has also recommended that Dearness Relief be paid to employed family pensioners and re-employed family pensioners. The Govt. of India has considered and accepted this recommendation. Accordingly, they have taken decision to allow Dearness Relief to the re-employed family pensioners.

3.- Keeping in view the decision taken by the Govt. of India and the ruling given by the Supreme Court of India on the subject in C.A. No. 5835 of 1998-Haryana State Electricity Board and others vs Azad Kaur and C.A. No. 679/97-Union of India and others vs Rekha Majhi, the State Govt. has reviewed the matter and taken the following decision:-

- a) All Family Pensioners in receipt of family pension/extra-ordinary pension from the State Govt. who got employment on their own or who were already in service under the State Govt./Central Govt. or any other State Govt. or a Corporation/Company/Body/Bank (otherwise than on compassionate ground) shall be eligible to draw Dearness Relief as applicable from time to time on the amount of family pension with effect from 18th July, 1997. The amount of arrear shall be payable.
- b) If the recipient of family pension/extra ordinary pension is employed/re-employed in the State Govt./Central Govt. on compassionate ground in lieu of the death of the employee in whose respect the family pension is sanctioned, the dearness relief on the family pension will not be admissible.
- c) If the recipient of family pension is also in receipt of service pension in respect of past government service, the dearness relief shall be determined on the total amount of the two pension.

The above instructions may kindly be brought to notice of all concerned under your administrative control.

**Subject:- Implementation of government's decisions-regarding
revision relating to pension etc.**

Sir,

I am directed to invite a reference to Punjab Govt. letter No. 1/10/99-5FPPC/12156 dated 6.4.2000/5.5.2000 on the subject cited above and to state that on receiving various representations the State Govt. adopted the formula laid down by Government of India for calculating the average emoluments in respect of the employees who retired between 1.1.96 to 30.6.96. Consequently clause regarding exercise of option in Para 2.(j) of Letter No. 1/10/99-5FPPC/12156 dated 16.7.99 to draw pension under the rules applicable before 1.1.96 as if the employee had retired on 31.12.95, was withdrawn. The State Government has received some other representations from pensioners that by adopting the new formula their pension has been considerably reduced.

2. Keeping in view the difficulties in this regard it has been decided that the right of option to adopt the package for the retiring dues (Pension, Commutation and DCRG) under the rules applicable before 1.1.96 may be restored to such pensioners who may choose to be governed by the old rules as if they had retired on 31.12.95.

3. It is requested that on the written request of the pensioners who may like to exercise an option under these instructions which will be final the retirement dues viz. pension, death-cum-retirement, gratuity, commutation of pension etc. may be re-calculated under the case sent to the Accountant General (AG).

4.- In view of the above, Para-3 of instructions dated 6.4.2000/5.5.2000 is deleted.

Sub:- Incentive for bringing buoyancy in revenue.

In order to bring buoyancy in revenue, the Board has decided to give incentive to one Divn. and one Sub Divn. in each Operation Zone achieving highest percentage increase in revenue over the expected during the year, 2000-2001 on the following terms & conditions:-

- i) In each Operation Zone One No.Divn.& one No.Sub Divn. achieving highest percentage increase in revenue over the expected during the year, 2000-2001 will be awarded Rs.50,000/-and Rs.30,000/- respectively as cash incentive. Further, one Divn. and one Sub Divn. achieving the highest increase in the Board shall be awarded additional incentives of Rs.1.00 lac & Rs.50,000/-respectively.
- ii) The incentive will be given in the form of additional contingent grant to be used to equip the offices.
- iii) 'Letter of Appreciation' will be given to the officers/Supervisory Staff of the Sub Divn. which excels in its zone provided the individual had worked in the office for not less than 90 days.
- iv) The Divisions/Sub-Divisions achieving highest percentage increase in revenue assessed over the expected shall be identified by the Chief Engineer/Op. and got verified from Chief Accounts Officer/Revenue, before according approval for payment of said incentive.

2. Further necessary action may be taken accordingly.

viii) Leave Travel Concession:

There shall be total freezing of availing of LTC from the date of issue of these instructions till March, 2002. However, officers/officials in whose case sanction to avail this concession has already been issued by the competent authority before the date of issue of these instructions shall be permitted to avail it but admissibility of their T.A. claim will be as per revised grading/rates, rail/Air Travel entitlements as above revised through these circular instructions. In case of commencement of journey before the issue of these instructions, the admissibility of TA claims shall be as per existing rates.
