ORDER

No. 435 /Fin-38/Vol-VII

Dated:- 4/4/91.

In continuation of this office order No. 432/Fin-38/
Vol-VII dated 8.11.1990, the Punjab State Electricity Board on
the pattern of Punjab Govt., is pleased to decide that the rates
of Dearness Allowance payable to the employees of the Board shall
stand modified with effect from 1st January, 1991 as follows:-

Date from which payable	Pay Range	Rate of Dearness Allowance per mensem.
1st January, 1991 onwards	Pay up to Rs. 3,500	51 (Fifty-One) per-cent of pay.
	Pay between Rs. 3,501 and upto Rs. 6,000.	38 (Thirty eight) percent of pay subject to a minimum of Rs. 1,785.
	Pay above Rs. 6,000.	33 (Thirty-three) percent of pay subject to a minimum of Rs. 2,230.

2. The 'Pay' for the purpose of these orders shall be the 'Pay' as defined in Regulation-2.45(i) of the PSEB MSR Volume-I Part-I, which is commonly known as 'Basic Pay' including Non-Practising Allowance and Stagnation increments in respect of employees drawing pay in the Revised Scales of Pay as per PSEB (Revised Pay) Regulations-1988. In the case of employees who have not opted for the revised scales of pay but continue to draw pay in the pre-revised scales of pay, the 'Pay' for the purpose of these orders will include, in addition to 'Basic Pay' the Dearness Allowance, Dearness Pay, adhoc Dearness Allowance and Interim Relief (wherever allowed) appropriate to that pay admissible under orders in existence on the 1st January, 1986. In terms of Punjab Government Notification No.3/1/5/IFCD/5938, dated the 11th July, 1990 (published in Punjab Government Gazette (Extra), dated the 31st July, 1990), the dearness allowance is not admissible on deputation allowance.


3. The payment on account of dearness allowance involving fraction of 50 paise or above may be rounded off to the next higher

rupee and the fraction of less than 50 paise may be ignored.

4. These orders are also applicable to the work-charged employees.

5. These orders will not be applicable to the staff paid from contingencies, casual labour, staff employed on daily wages and those working on piece -rate system. These orders will also not be applicable to those employed on contract basis except where dearness allowance is admissible in terms of their contract.

6. A Ready Reckoners showing the amount of dearness allowance payable in cash from 1st January, 1991 onwards in terms of these orders is appended (Appendix).




