Subject: Grant of Dearness Relief to the Pensioners of the Government of Punjab, beyond the average Consumer Price Index-608.

Sir/Madam,

I am directed to invite a reference to Punjab Government letter No. 16/66/84-IFP-III/6132, dated 24th June, 1988, issued by this department and to say that the President of India is pleased to decide that Dearness Relief shall be paid to the Pensioners/Family Pensioners of the Punjab State to compensate for the rise in the cost of living beyond average Consumer Price Index Level 608 at the following rates with effect from 1st July, 1988, in modification of the rates mentioned in the letter dated 24th June, 1988 :-

Pension/Family Pension per month plus Adhoc Relief admissible upto 1.1.86 plus Interim Relief granted w.e.f. 1.1.86 wherever admissible.	Rate of Dearness Relief per month.
(I) Not exceeding Rs. 1,750.	23% of the Pension/Family Pension.
(II) Exceeding Rs. 1,750 but not exceeding Rs. 3,000.	17% of the Pension/Family Pension subject to a minimum of Rs. 403.
(III) Exceeding Rs. 3,000.	15% of Pension subject to a minimum of Rs. 510.

1.2. Payment of Dearness Relief involving a fraction of a rupee shall be rounded off to the next higher rupee.

1.3. Other provisions contained in Finance Department letter No. 16/66/84-IFP-III/8181, dated 15th July, 1987, governing grant of Dearness Relief to the Pensioners/Family Pensioners will remain unchanged.

-: 4 :-

1.4. A Ready Reckoner showing Dearness Relief payable from 1st July, 1938 onwards, in terms of these orders, is enclosed.

2.- The expenditure involved will be debitable to the Head "2071-Pension and other Retirement benefits."

3.- The liability in respect of the Pre, 1st November, 1966 service of the Pensioners/employees (in respect of family pensioners) of the Government of Punjab, shall be divisible amongst the successor States of the erstwhile State of Punjab, namely, Haryana, Himachal Pradesh and Union Territory, Chandigarh in terms of 14th Schedule of the Punjab Reorganisation Act, 1966.


The Punjab State Electricity Board (Revised Pay) Regulations, 1988, have since been notified by the PSEB vide O/O No. 129/PRC/Fin. dated 11-11-1988. In the said regulations, the revised scales of pay upto Group-XII have been notified and separately the revised rates of certain allowances, special pay etc. admissible on the revised scales have also been circulated. After obtaining options of the employees in accordance with the provisions of the said regulations, the pay is to be fixed in the revised scale under the provisions of the said regulations. In order to ensure that the regulations and orders notified/issued by this office are observed/followed with due regularity and propriety from the audit point of view, it has been decided that payment of arrears would be made after the fixation of pay has been scrutinised by the Senior Accounts Officers/Accounts Officers as under :-

- i) Sr.A.O.,/A.O., in the pre-audit offices at various Projects. In respect of employees posted at the respective Projects.
- ii) Accounts Officer/P&A (CAO office). In respect of employees whose pay is drawn by the Pay & Accounts Section.



- iii) Accounts Officer EAD (CAO Office). In respect of employees posted in the Board's Secretariat, C.E. Offices situated at Patiala, including their subordinate offices whose pay is pre-audited by EAD Section and CAO, CA, FA and DIG (V&S).
- iv) Accounts Officers/Field under Chief Auditor. In respect of employees posted in Distribution charges within their respective jurisdictions, Chief Engineer(North) Jalandhar and Engineer-in-Chief, Ludhiana.


2.- The audit staff as mentioned above shall start checking the cases of pay fixation in the revised scales with immediate effect. It is therefore, requested that full co-operation may be extended to the audit for this task.
