

Sub:- Implementations of the recommendations of the Third  
Punjab Pay Commission-City Compensatory Allowance and  
special Compensatory Allowance to the Punjab Government  
Employees posted at Delhi.

I am directed to invite your attention to the subject cited  
above and to say that in pursuance of the recommendations of the  
Third Punjab Pay Commission, the president of India is pleased  
to decide that the rates of City Compensatory Allowance admissi-  
ble to the Punjab-Government employees posted in various agencies  
of the State Government at Delhi shall stand revised to the same  
rates as the Chandigarh Compensatory Allowance admissible to the  
employees posted at Chandigarh and Sahibzada Ajit Singh Nagar  
(District Ropar), that is, at the rate of Rs. 100 per month for  
all pay ranges with effect from 1.9.1988.

2. The president of India is further pleased to decide that  
the rates of special Compensatory Allowance admissible to the  
Class-III and IV employees in terms of this Department's circular  
letter No. 6650-5FP/20769 dated the 3rd Sept. 1975, shall stand  
revised to double the rates of Chandigarh Compensatory Allowance,  
that is, to Rs. 200 per month for all pay ranges (of class III and  
IV employees only) with effect from 1.12.1989. The grant of  
Special Compensatory Allowance in addition to the City Com-  
pensatory Allowance mentioned in para 1 above, shall be subject  
to the following conditions:-

- i) Service staff like that of the Hospitality Department  
and the Drivers required to reside on the Punjab/  
Kapurthala/Nabha Estates should be given the rent free  
accommodation without the special compensatory allowance.
- ii) Such of the personnel of the Punjab Government as  
voluntarily avail themselves of accommodation at the  
rate of 5% of their pay in any of the Punjab Govern-  
ment residences in Delhi will not be given a Special  
Compensatory Allowance.

iii) Those availing themselves of Government accommodation at 5% of their pay, will not be given special Compensatory Allowance.

3.- These allowances will be admissible on the same condition on which Chandigarh Compensatory Allowance is admissible to the Punjab-Government Employees posted at Chandigarh.

Sub:- Clarification in respect of grant of Promotional/  
Devised Promotional Scale.

Please refer to this office order No. 197/Fin/ PRC-1988, office order No. 198/Fin/PRC-1988 both dated 23.4.90 and office order No. 201/PRC/Fin-1990 dated 3.5.90, regarding the grant of Promotional/Devised Promotional scales. Certain points have been raised for/in respect of grant of promotional/Devised Promotional scales, the procedure for which was laid down in the office order dated 23.4.90. The matter has been considered in detail and the following clarifications are given to the various points:-

<u>Points</u>	<u>Clarification</u>
1. How many promotional increments are to be granted in case of any official who has availed the benefit of 8/18 years proficiency step up. Whether the provision of para-8 of Office Order No. 138 dt. 5.1.1989 applies.	As per para-8 of O/O No. 138 dt. 5.1.89, the employees who will be placed in the time bound promotional/ devised promotional scale on completion of 9/16 years service will get only one increment on their placement to first promotional scale. The benefit of second proficiency step up increments on completion of 16 years service will not be admissible to the employees after placement in the second promotional scale.

S.No.

Points

2. Whether after promotional scale, one is entitled for proficiency step-up because the post remains the same.
3. What would be the effect of stoppage of increments with or without effect for computing regular service.
4. Whether promotion without any financial benefit is to be counted as promotion. Somewhere in 1955-56, a promotion of Oiler & Cleaner to the post of ALM was without any benefit. There might be some other post too.
5. How intervening period falling between reversion and re-promotion is to be treated for the purpose of regular service.
6. What will be effect if an employee foregoes a promotion.
7. Whether extra ordinary leave on medical grounds without wages and countable towards increment will affect the regular service.
- Otherwise service adjudged to be suitable for admissibility of time bound promotional/ devised promotional scale.
8. Whether the post of LM-II & Linesman-I is to be treated as one post on the analogy of post of AE/AEE.
9. Whether the period treated as 'DIES NON' will postpone the benefit of promotional scale.

Clarifications

The employees placed in second promotional scale on completion of 16 years service are not eligible for second proficiency step-up.

There would be no effect of stoppage of increment (with or without effect) for computing 9/16 years regular service. However, the competent authority would consider work and conduct and other record while granting promotional scales.

The benefit of time bound promotional/devised promotional scale will become available to the employee on completion of 9 (Nine) years regular service on a post. Accordingly the service rendered on one post is only to be considered.

The period falling between reversion/re-promotion is to be treated on lower post as if he has been continuing on the same post before promotion.


The employee who foregoes his promotion will not be entitled for promotional/devised promotional scale on completion of 9/16 years service.

The period of extra-ordinary leave on medical grounds only without pay (where the original seniority of the employee is not disturbed) will count towards regular service for the grant of promotional/devised promotional scales to the employee concerned.

The post of Linesman Gr.II and Linesman Gr.I is to be treated as one post as the post of Linesman Gr.II subsumed and designated as Linesman.

The matter is under consideration. The benefit of 'DIES NON' period should not be given till further orders.

- ... 3 ...
10. An employee with a service of 20 years on 1.1.86 will avail 1st promotional scale on 1.1.86 and 2nd on 1.1.89 as per instructions, but when he would be entitled for the benefit of 23 years service on 1.1.1989.
- The employees who have got benefit of either of 9/16 years, time bound promotional devised promotional scale are not entitled to 23 yrs service benefit.
11. Who and who will be the competent authority for different categories for the grant of promotional scales.
- The promoting authority of the employee concerned will be the authority competent to grant time bound promotional scale/devised promotional scales.
12. Whether the act of devining the scale below the minimum scale of a promotional post, at the level of the Divisional office will be legally in orders.
- Divisional offices are not authorised to devise the promotional scales. The scale will be devised and circulated by the Secretary (Finance Section) of the Board.
13. Grant of benefit of minimum two increments on promotion w.e.f. 1.1.86 as the same scheme for grant of time bound promotional/devined promotional scales has been ordered w.e.f. 11.11.88.
- The promotional increments are governed by para-8 which is based on the Punjab Govt. Notification dated 13.9.88 circular vide o/o No. 129/PRC/Finance dated 11.11.88 whereby two promotional increments will be admissible to the employee who is promoted after 11th November, 1988. Similarly an employee who is allowed time bound promotional/devised promotional scale will be entitled for two promotional increments provided the employee if promoted after getting proficiency increment(s) he may be allowed one increment. The employees getting benefit of the time bound promotional scale between 1.1.86 to 11.11.88 will be eligible for one increment only.
14. Adhoc service countable towards regular increments pay and seniority should be computed for the grant of proficiency Step-up(s). It is stated to be not countable for the grant of Proficiency Step-up in Para-6 of Secretary(Finance) Circular No. 64/89, Memo No. 210246/896 /Fin.I/938/L-VI dt. 4.10.89.
- The service starting from the date of entry into the regular service only of the PSEB will be taken into consideration for the grant of Proficiency Step-up.
