Subject:- Implementation of the recommendations of the Fourth Punjab Pay Commission-Grant of Fixed Medical Allowance to Punjab Government employees/Pensioners on uniform basis for outdoor treatment, without any option.

\*\*\*

I am directed to invite reference to Punjab Government letter No. 5/22/97-1FPI/11179 dated 31.12.97 on the subject cited above and to say that on further consideration of the matter, the Governor of Punjab is pleased to decide that the word 'pensioners' shall include persons in receipt of family pension. The benefit of fixed Medical Allowance shall be available to such person/ persons if she/he is not in the employment of any State/Central Government or any Public Undertaking, Local authority or any other such institution, and if so employed is not availing facility of reimbursement of cost of outdoor treatment for her/his own treatment or the treatment of members of her/his family.

For this purpose a declaration in the enclosed Form shall have to be furnished by the person in receipt of family pension to the Disbursing Authority.

This will also apply in case of Widow/widower who have remarried but drawing pension as natural guardian of minor children.





The Punjab State Elec. Board is pleased to enhance the rates of Shift Duty Allowance admissible to its employees posted on shift duty at Thermal Plants and Hydro Power Houses w.e.f. 1.9.97 as under :-

Note: The Shift Duty Allowance is admissible only to those employees who are engaged in three shifts Operation/maintenance, including night shifts.

2. The PSEB is further pleased to sanction Shift Duty Allowance @ Rs.200/- P.M. to AAEs(Sub-Station) working in three shifts round the clock in 220 KV Grid Sub-Stations and also to their counterparts/JE(Sub-Station) working in 132/66/33 KV Grid Sub-Stations who discharge shift duty for a period of minimum 15 days in a month, as shift reliever or otherwise due to shortage of shift duty staff with immediate effect on the following terms & conditions :-

- i) This allowance will not be admissible during the periods of training, suspension and leave of any kind other than casual leave ;
- ii) This allowance will also not be payable to the AAE/JE(Sub-Station) put on general duty.
- iii) Sr. XEN/SSE/AE concerned will certify that AAE/JE

days of weekly rest or in the exigency of leave/  
vacancy of shift duty staff and has not availed of  
compensatory leave on this account.

3. The arrears accruing on account of this increase upto 31.8.99 may be credited to G.P.F account and payable in cash w.e.f. 1.9.99. In the case of employees who have not been allotted account number in the G.P.F., the amount of arrear shall be invested in NSCs or NSS or Kissan Vikas Patras or Indira Vikas Patras. In the case of employees who have retired from service of the Board or are due to retire by 31.10.99 and have closed their G.P.F account, the arrears of the whole period shall be paid in cash.
